
1. Adoption of the agenda

2. Organizational and other matters

The fifty-eighth session of the Committee will be held at the United Nations Office at Geneva, in Palais Wilson, from 25 July to 12 August 2016, and will be opened by a representative of the Secretary-General. The first meeting will be convened on Monday, 25 July 2016, at 10 a.m.

Pursuant to rule 31 of the rules of procedure, the meetings of the Committee will be held in public, unless the Committee decides otherwise or it appears from the relevant provisions of the Convention that the meetings should be held in private.

The Committee will consider its programme of work for the session, its working methods, its draft general comments and any other matter concerning the modalities of discharging its functions under the Convention.
