Recognizing the seriousness of the human rights challenges that arise in the context of migration, OHCHR and CMW have been working to address human rights protection gaps, including by assisting Member States, civil society, national human rights institutions, and other stakeholders.

As part of these efforts, OHCHR has developed and published this Training Guide and accompanying training materials, which are designed to enable participants to understand the human rights perspective on migration, and how human rights laws and standards can be operationalized to enable participants to adopt a human rights-based approach in their work on migration and to make migration safer and an empowering experience for all.
