## Excellency,

In my capacity as Rapporteur on Follow-up on Concluding Observations of the Committee on the Elimination of Discrimination against Women (CEDAW), I have the honor to refer to the examination of the combined fourth and fifth periodic reports of Namibia, at the Committee's sixty-first session, held in July 2015. At the end of that session, the Committee's concluding observations (CEDAW/C/NAM/CO/4-5) were transmitted to your Permanent Mission. You may recall that in paragraph 48 on follow-up on the concluding observations, the Committee requested Namibia to provide, within two years, written information on the steps taken to implement the recommendations contained in paragraphs 11 and 15 of the concluding observations, namely:

- "11. The Committee calls upon the State party:
- (a) To adopt a comprehensive legal definition of discrimination in line with article 1 of the Convention, covering all prohibited grounds of discrimination, including marital and other status, either by amending article 10 of the Constitution or by adopting other appropriate legislation;
- (b) To urgently adopt pending bills, such as those on marriage, recognition of customary marriages, procurement, marital property, divorce and intestate succession"
- "15. The Committee recommends that the State party ensure that adequate funding is provided to the legal aid fund and that women, in particular women pursuing divorce and gender-based violence cases, have effective access to justice in all parts of the State party"

Although the information sought by the Committee was due in July 2017, only the 2016-2020 National Plan of Action for the implementation of the concluding observations made by the UN Committee that monitors the CEDAW has been received to date. Accordingly, I would be grateful for clarification as to the current status of your Government's response and implementation on the above cited matters.

The Committee looks forward to pursuing the constructive dialogue it has started with the authorities of Namibia on the implementation of the Convention. In this context, the Committee seeks to receive your response to this reminder within one month of the date of this correspondence.
