GAMBIAN DELEGATION TO GENEVA**

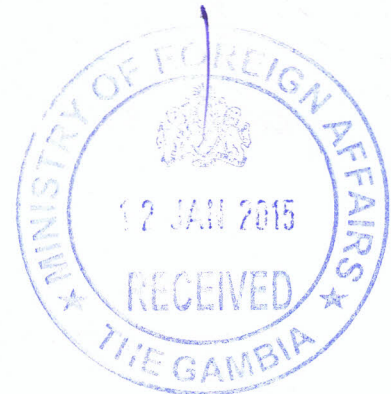
