Explaining the Yearly Breakdown

- Between 18 December 2014 and 10 March 2015, Pakistan executed 24 convicts. Since then, the • number is 444. These dates are significant because until March 2015, only those convicted under terrorism charges were being executed. On 10 March 2015, the Interior Ministry issued that death penalty be resumed for all capital offences.³
- There was a 73% decline in executions from 2015 to 2016. Despite the stark decline, Pakistan • remained one of the top executing states in the world for the year.

- Of the 88 executions in 2016, only two were carried out after July 2016. Between July 2016 and February 2017 **only 6** executions were carried out. This near-total stoppage of executions in the latter half of the year can be credited to the tireless efforts of human rights organizations.
- However, February 2017 saw an uptick of militant attacks and in response "Operation *Rad-ul-Fasad*" was launched. Since February the rate of executions has therefore risen alarmingly.
- The year 2017 has so far seen **48** executions in Pakistan out of which at least **38** were convicted by military courts whereas in the year 2016 only 6 people tried in military courts were hanged.
- It is important to note that this is the same period when the tenure of military courts was scheduled to end and the efforts to give an extension to the military courts were being carried out by the ruling party.

• The city-by-city breakdown clearly shows that a significant majority of executions being carried out in Pakistan are in the province of Punjab. Incidentally, Pakistan's ruling party, the PML-N, only has a provincial government in Punjab out of Pakistan's four provinces.
