We here would like to submit a report related to a gross human rights violation committed by Japanese Child Consultation Centers (CCC), Welfare Civil Servants, Schools, Board of Education, Family Courts, Divorce CCC Kidnapping Lawyers, and CCC Child Psychiatrists who repeatedly misdiagnose, lock healthy children into closed wards and psychotropic drug them to be disabled.

INTRODUCTION

We are a group of parents and children whose children were being bullied at schools, then abducted and confined by Child Counseling Centers (CCC). Concerning to Japanese Schools and CCCs, we our families are subjected to terrible human rights violations.

In Japan, bullying=ijime is rampant in schools. Parents and children who had talked with school teachers about their children being bullied were kidnapped by the Child Counseling Centers, accusing them of domestic abuse in order to cover up or silence their school bullying. The board of education does not make any effort to solve the problem of school bullying=ijime. Victims of school bullying could not attend to school, become depressed and attempt suicide.

Japanese educational and school environment in which children are placed into is very poor, teachers and public workers who have found school bullying = ijime do never try to solve it. They replace school bullying ijime with home and parental abuse problems, then Child Counseling Centers (CCC) kidnap those school bullied children, and thus CCC hush up the school bully problems.

Outside of school, in Japan, bullying=ijime is epidemic in society as a whole. Even with the spread of the new coronavirus infection, attacks such as slander and defamation have intensified, and even gag orders have been issued. There is a strong tendency to place excessive emphasis on the identity of the group. We accept information provided by the media without question and take excessive measures to be the same of others and to prevent being attacked. Domestically, it's easy to start a business just by inciting fear caused by being not-identic to other people.

Public schools, Child Counseling Centers (CCC), and DV Centers are government agencies basically responsible for the social welfare, so they should not do kidnapping and family destruction businesses. The same applies to family courts and the Children's Human Rights Committee of the Japan Lawyers Associations. However, due to the legal reform in 1999, the bar examination became easier, and the number of lawyers lacking aptitude and qualifications are increasing and became saturated. For those poor qualified lawyers, abducting children and destroying families for money are turning into businesses. Family Court has become employment agencies for welfare civil servants and professionals who prey on kidnapped children. The government's policy of aggressively destroying families deliberately created trouble within the family, and based on the method of actively encouraging divorce, the budget was allocated to the excessive number of public welfare workers and low qualified legal professionals. It goes without saying that these family destruction national policies have accelerated the unmarried rate, the divorce rate, and the declining birthrate in Japan, and have weakened the national power.

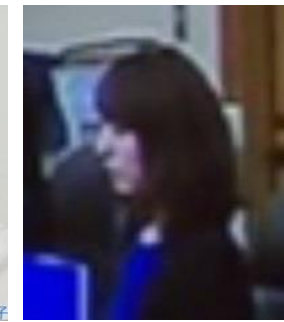

尋問日には、被告代表者 被告の専断が予定されており、両人が協議に来ることが予定されること、原告が、被告と権利を争うことで、原告が抱えるストレスはさらに高くなることを容易に予測され、自らの意思を自由に表わすことができなくなるおそれを指摘してまいります。
このような状況から、共同親権203条の3第1項の「圧迫を受け精神の平穏を著しく害されるおそれがある」と認められまますので、原告被告間に共同親権を認めていただきたく、上申致します。
2 被告は、共同親権推進の強行的な活動を繰り返しております。共同親権推進の人は、両人の相手方たる配偶者が出席する第1審の期日を明らかにし、傍聴席を共同親権推進メンバーで埋め尽くすことを呼びかけ、裁判官に対して、精神的圧力をかけることを繰り返しております(資料1乃至16)。
そして、被告は、同じく自らが高まるTwitterアカウント「ドクターK」で高子裁判官は悪徳です! (lonely_docto) において、共同親権推進のフォロワー等に呼びかけ、煽り直し、騒ぎ事件の存在、尋問期日の日、傍聴席を埋めかする数値を行っています(資料17乃至18)。
被告が投稿した尋問期日に際するツイートに対しては、傍聴席において、原告代理人弁護士の録音を通すことにより期日そのものを妨害する予告もなされております。

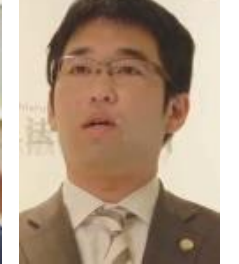

CASE1

Hamamatsu Child Consultation Center (CCC) Has Abducted Her Daughter, Psychotropic Drugged and Brainwashed Her and Driven Her Father to Death as a Sexual Abuse Offender

Her daughter, who was attending one private junior high school (in the first year junior high school, 13 years old at the time), suddenly attempted to commit suicide by hanging. Her daughter would be bullied by girls at the school, and she attended to school consultative sessions. Also, her daughter was told by the school that she would be suspended to attend the school until she could see a child psychiatrist. In Japan, as it takes a considerable amount of time before the first visit to a child psychiatrist, for a girl who has never been seen by a child psychiatrist, fulfilling this requirement to return to school was equivalent to declaring expulsion from school. Her mother and her father were naturally dissatisfied with this school's correspondence to school bullies and their daughter's attempted suicide, but they realized that it would be wrong to expect the school's conscientious interaction. They had also experienced that their younger son was bullied by three boys in a summer pool at the elementary school, his head was held down by them and he was deeply submerged many times into the water. Even seven years have passed since then, and their younger son is in the state of never being able to enter the pool at the school. But the school teachers and the Hamamatsu city board of education have continued to ignore the school bullying and faked that there was no bullying at any school in this city. Considering the case of school pool bullying of their younger son, it would be a mistake to expect the school to clarify the facts. Judging the school's dishonest response to hide school bullying inappropriately, the parent repeatedly urged their daughter to transfer schools immediately after she had attempted suicide. This is because their daughter herself said, "I was treated as a troublemaker by the school, but I would change the school when entering the high school" As her parent, the mother was worried so much, but since her daughter wanted to return to the school, the mother had no choice but to take turns picking her daughter up from and to school, watching over her and staying close to her.

One year and two months after their daughter attempted suicide, then she was suddenly taken into 4years custody at Child Consultation Center (CCC). It was accused of "suspected sexual abuse by her father", of course that was a false accusation. When her mother had interviewed with her daughter during her CCC's custody, the daughter was so agitated and excited under deteriorating mental condition that the school and the CCC allowed this mother to see her daughter for only 3 minutes. The CCC told the mother to "investigate", so the mother was convinced that there would be no such facts of sexual abuse by her father if a thorough investigation was carried out, so the mother agreed to CCC's custody. Immediately after being placed in CCC's custody, the mother found that her daughter had been self-harming (cutting her wrist) and the mother judged that her daughter's mental condition was extremely unstable, and the mother requested her daughter to be hospitalized as soon as possible. However, after her daughter was interviewed by the public prosecutor (5 times), the daughter was finally hospitalized for medical protection (6 months) after a month and a half from CCC's temporary protection.

Her daughter's medical information was never disclosed to her parents, and no explanation was given about the extension of the period of hospitalization at the child psychiatrist. The Child Consultation Center (CCC) deceived the Family Court and passed the Article 28 judgment to send her daughter to CCC's Psychotherapy institution.

A junior high school teacher who appeared in court at the trial generally accepted the incident involving her daughter and the daughter's friends' ignoring, slandering and ostracizing at school, but he testified that he "did not recognize it as school bullying." In the criminal proceedings, there was a school record of 20 psychological sessions and interviews in a junior high school psychology room after her daughter's attempted suicide until she was temporarily put into CCC's custody. Therefore, during these psychological sessions as of EMDR (Eye Movement Desensitization and Reprocessing) and Pulsar Method, it was assumed that false memories were implanted and memory confusion occurred to her daughter.

The daughter's diagnosis was PTSD, as evidenced by her medical examiner (attending physician), but ruled out the effects of her bullied school experiences and refused to her medical records. In the doctor's medical record before hospitalization, there was a description of PTSD and her daughter's school bullied experiences. In addition, her daughter was being dosed psychotropic drugs without her parent's consent, and she was being questioned as a sexual victim at the court. She was also diagnosed as schizophrenia, and the credibility of her statement was questioned. The daughter's obstetrician-gynecologist's medical record is also not disclosed. Their younger son has long-term school refusal and depression due to the shock of his father's death and his sister's abduction and confinement by CCC, and is diagnosed with ASD. As a result of reasonable consideration such as environmental adjustment by the school side while still in the regular class, their younger brother's school refusal gradually improved and he could enter high school.

After her daughter was detained at CCC's facility, her father had been accused of sexual abuse to his daughter and suddenly he had died in the pretrial detention (death of heart disease due to depression and hypertension under the long-term detention), and the case could not be resolved because the requirements for requesting a retrial were not met. The daughter was sent to CCC's institution, and family-daughter discontinuation and communication cutoff have been continued. Every member of her family is heartbroken and traumatized by CCC's arrest of their daughter. As a similar victim by Child Consultation Center of Japan, we hope that the United Nations Commission on the Human Rights of the Child never allow any decisions that

destroy Japanese families, damage children's future, and condone child abuses by Japanese administrative authority.

The father was convicted without medical evidence. He died suddenly (myocardial infraction) in prison.

前出の黒田医師も、エリスンに対して行なわれている治療方針は、J・G・ガンダーソンの治療方針とは対極に位置づけられるものであると批判している。

「すでに死じた父親だけでなく、母親や、本人との関係が良好であった、母方の祖母との同席面接はおろか、面会さえ1年以上にわたり完全に禁止され続けている現状は異様としか言いようがない。ひょっとするとこれは治療方針というより、親族と面会することに、本児が強く反対しているためかも知れないが、それはむしろガンダーソンの性的虐待事件の真相を暴く!」

おかしい裁判の実態

弁護士が「起訴すらあり得ない」と断っていた事件で有罪判決が下ったのは、今年の3月に衝撃的な性虐待の無罪判決が連発し、それに世論が大反発したことと無縁ではな

にも該当するものであることを認めています。本児童の主治医は申告された「父親からの性的虐待」に対する対応に追われていたため、やむを得ない面もあったかも知れないが、BPDに対するきちんとした構造化面接を行なっていたなら、本児童がBPDの診断基準を満たしていた可能性は決して少なくなかったのではと思われまます。

本児童がBPDに罹患しているかどうかを検討しておくことが重要なのは、それが本児童の行なっている「父親からの性的虐待申告」に対して、どのように治療方針を取るかを規定するためです。「家族からの性的虐待を受けた」というBPD患者の申告に対して、BPD研究及び治療の第一人者であるJ・G・ガンダーソンは、次のような治療方針を勧めることを推奨しています。『父親とみるべきである。そうすることによって、あるいは虚偽の申し立てを行なっている可能性がある。』

● やましいことのある両親は、子どもとの同席面接に参加しようとしないうことが多い。

● 無実の両親を誹謗する、あるいは患者が被害者としての自己認識を持つのを助長することは、いずれも悲慘な形で患者の疎外感を水酸化し、この障害が慢性化する一因となる可能性がある。

久患さんは、児童相談所と精神科医に「娘は境界性パーソナリティ障害ではないのか」と相談した。だが「違う、PTSDだ」との一点張りだったと言った。六相で、「嘘をついても娘さんには何のメリットもない」と判断された主人は有罪判決を受けましたが「自分が一番愛している人、大切にしている人を攻撃して互いに傷つくことをしてしまおう」というのが境界性パーソナリティ障害の特徴なので、杉山医師の著書の内容と照らし合わせてみると、自閉症スペクトラム障害、ADHD(注意欠陥多動性障害)に出して薬を娘のエリスンに出して書いた。しかも、杉山医師は著書に自閉症スペクトラムから境界性パーソナリティ障害に発展すると記している。意図はよく分からないが、つまり、境界性パーソナリティ障害、あるいはそれに近い精神障害であることを知っているが、PTSDという違う病名を初診で付けたのだ。

「うちの子どもは3人ともADHDの傾向があることは前から気づいていました。遺伝的なものかもしれないですね。次男も事件以来自閉症になり、ついこの前、医師からASD(自閉スペクトラム障害)だと診断されました。その前にはうつ病だと診断されていましたが、それで処方薬を確かめたところやはり娘と同じ薬でした。境界性パーソナリティ障害の人たちの自殺率の高さを考えると、娘をちゃんと治療し、ケアしてあげなければ大変なことになってしまう。親

主張を裏付ける可能性があると「言うのだ。」

そして、こう結論づけている。

「恐怖な形で患者の疎外感を水酸化し、この障害が慢性化するのを阻止するためにも、BPDという診断を最初から除外するような立場を取ることもない臨床家が、家族・親族・友人の協力をできる限り得るよう努力した上で、診断面接をやり直すことが望ましいと思われまます」

いだろう。しかも、そのなかの驚くべき無罪判決のひとつに山田直之裁判長が絡んでいるのだ。

静岡県磐田市で当時25歳だった女性をナンパして強姦、けがを負わせて強制性交致傷の罪に問われたメキシコ国籍の男性被告(当時28歳)に今年3月19日、静岡地裁判決

松支部の山田直之裁判長は、「故意が認められない」として無罪判決を言い渡した。検察側は、「被告の暴行で女性の反抗が著しく困難になるのは明らか」だと主張したが、山田裁判長は、「被告が加えた暴行が女性の反抗を困難にする」と認識していたと認めるには、合理的な疑いが残る」

CASE 2

IWATE Child Consultation Center (CCC) Abducted My Only Daughter, Without Parental Consent Psychotropic Drugged and Brainwashed Her

My only daughter (then she was 13 years old, in the 1st year of junior high school) was being bullied at school, and I as her Mother had been consulting with the school teachers about her bullied. My daughter had five meetings with the school counselor. One day she had not returned home, I was looking around for two hours, I found out that she had been taken into temporary custody by Child Consultation Center (CCC). I went over CCC and asked, "Is my daughter really safe?" I was worrying about her so much. Our family has just a mother and the only daughter without a father.

From the beginning of the temporary protection by CCC, the school teachers fabricated that I had abused my daughter in order to cover school bullying. Of course I as her mother I never had abused my daughter, I swear. As a result, I was accused of false accusations that were not true. When my daughter was placed in temporary custody by CCC, I was not given an opportunity to defend myself. There was no leeway in life in our single-mother household, but the intervention of Child Consultation Center (CCC) destroyed the modest life of just the two of us, and I had to spend time every day taking time to meet with the staff of CCC, and I was mentally exhausted.

I used to work as a part-timer, but after my daughter was abducted by the Child Consultation Center (CCC), I couldn't understand any verbal instructions from my boss at work. On the way back home by car, I noticed that I was running and ignoring at red light three times. I thought that I should not cause any more troubles to my employer about my daughter and CCC, so I ended up quitting my part-time job, and my financial life became even more difficult. Since I had no supporters and I had completely submitted to the Child Consultation Center (CCC), CCC immediately decided to place her into foster care without her mother's consent, but it was canceled on that day. The reason for the cancellation was suspicion of my daughter's theft in the CCC facility, in fact, she was faked to be suspected of theft in the CCC facility and was transferred to Psychotherapy Treatment facility. In there she was falsely accused of sexual deviance and was locked up in an isolation ward because she said "She wanted to go back home, and my mom never abused her". She was forced to see a child psychiatrist and given psychotropic drugs, which worsened her mental state and they did let this girl never say "I want to go home and see my mom".

The abduction and confinement of my daughter by the Child Guidance Center (CCC) had lasted for about two years, and as a result our family have been exposed to local false prejudice as "abusive parent" and "mal-treatment family", my daughter was forced to transfer schools. There was a period when she was not able to attend school because she was arrested in the CCC facility, due to the loss of her educational opportunities, my daughter could not go to the high school she wanted to go attend.

Therefore, my daughter has been undergoing self-study to catch up her desired course, but in the first place, due to CCC's detention in the first semester of junior high school, there are parts where she does not understand how to take classes, and she is still losing the opportunity to receive proper education. Recently, she took the school medical check and her visual impairment due to psychological factors was revealed. Due to her transfer to another school, she is separated from her close friends without even say goodbye. My daughter had to change her places of residence many times during the CCC custody of about 2 years, so she still has anxiety symptoms of Regressive Symptoms in infants due to family separation, she has been deeply traumatized by the separation from her mother.

The Child Consultation Center (CCC) has treated me and my daughter as nuisances, tumors, and abnormal in our school and society, CCC has hindered the growth of her, and destroyed our family. I and My daughter were forced to change schools and move houses, and lost the leeway of our daily life. I don't want to allow CCC that they "destroyed family" under the guise of "family support."

NIIGATA Child Consultation Center Kidnapped My Son and Severed Our Parenthood For 3 Years

I am a father (hereinafter referred to as father). My only son was abducted by Japanese Child Consultation Centers (CCC) and confined into CCC's institution for over 3 years and a half. During these years, family relationship between father and son was completely severed, and our communication was also cut off. Japanese Child Consultation Centers (CCC) destroyed our family and ruined my son's future. After my son is coming back home on the 5th August 2022, over these past week, I've been talking to my son (currently in the 2nd grade, hereinafter referred to as my son) while keeping an eye on him. In the process, I found many facts about the responses and measures taken by Child Consultation Centers (CCC) that I thought were unfair, and I would like to describe them below. If necessary, I am willing to submit recordings of interviews with CCC as evidence, and to respond to testimony. After 24 years as an instructor at Preparatory School, I am now in his 9th year as a private high school teacher and I also hold a master's degree in psychology (Hiroshima University).

It all started in 2019, when his son made a phone call to the Child Welfare Officer in charge about our family and suddenly he was taken into CCC's custody. After that, the son was completely cut off from his father, relatives, acquaintances, and friends, and was made to believe that contact and communication were completely prohibited. This time, my son looked at the petition for Article 28 adjudication from CCC, and found that "statements that are not true," "some facts are distorted and give a different impression," and "the son's words were cut out in fragments and his intentions were distorted intentionally." He is indignant that most of them are false and his claiming is totally different.

Here is an example of the many statements that differ from the facts. In the complaint filed by CCC, there is an allegation that "my son kicked another child in the side at the temporary CCC's facility," but this is not true. According to my son, there were children running naked in the facility and children kicking down the walls of the facility, and it was an unsettling environment. The general care (nurturing, education) for the children in the facility was inadequate, and the children were under constant stress, causing frequent troubles. The son describes the CCC's temporary institution as "an environment worse than a prison." In addition, he said that he was abused at the children's home, such as being grabbed by the neck by the child welfare officer (Shunzo Kato) who was in charge of him (already reported to the Children's Family Division of Niigata Prefecture).

Also, when my son was in temporary custody, CCC conducted an intelligence test on my son and was diagnosed as having "a tendency toward developmental disorders". Instead, my son asked for cooperation with an institution specializing in developmental disabilities in Niigata Prefecture, but this was refused because "There is no problem". The CCC staff also neglected to deal with my son's career path and learning situation, and when my son, who was in the third year of junior high school at the time, went on to high school, I as his father presented multiple options based on his son's characteristics and conditions, and told this to Mr. Kato. Mr. Kato did not respond and ignored this. These actions are considered to violate the Act on Support for Persons with Developmental Disabilities. Since the second year of high school, my son has been truant and repeated grades, and now he has no choice but to be expelled from and change schools. This time, he returned home

because he had to repeat a year in high school and had to transfer schools.

"The above is just a small portion." There are too many things to mention that are considered unfair regarding CCC and its facilities. Although the CCC's response is to promote "family support" and "the best welfare for the child", it is just a false, and both the father and the son are indignant, and the child's troubles have increased. On the other hand, Child Consultation Centers (CCC) abuse their powerful authority and repeatedly commit acts that violate the rights of families and children. The response of CCC is immature, and I don't think it has a high level of expertise. Even the contents of the petition do not state the facts.

In the court, the content of CCC office's petition never be "truly true", and the child consultation center (CCC) never be conducting consultation support activities described in the "Management Guidelines for Child Guidance Centers". We, the parents and children hope that CCC would really promote the welfare of children and protect the rights of children. We have detected unfair and illegal responses by child consultation centers (CCC) and we hope the UN Commission on Human Rights of the Child to make appropriate judgments. This is to be submitted as a written opinion.

Family Reunification, After my son was released from Child Consultation Center' s (CCC) Facility, we spent a peaceful time on trips, making supper and bonfire on the riverside hill in order to heal his emotional PTSD wounds that was made by CCC kidnapping and 3 years confinement.



Hamamatsu School Teachers and Board Had Covered Up School Bullying on My Daughter

On August 23, 2022, an apology press conference was held at the Hamamatsu City Hall for my only daughter (currently She is 18 years old) being bullied in elementary and junior high school days. The school and Hamamatsu city had not been responding appropriately for these school bullies problem.

12 press members were coming for interview, so if you refer to news articles, you will understand the circumstances easily. Mr. Miyazaki as a Hamamatsu City's superintendent of education and these executives of the board of education apologized directly to my daughter. After that interview, seven teachers, including my daughter's homeroom teacher and the principal of her junior high school at the time, respectively in private read aloud apologies to my daughter and her parents. In the March 2022, school bullies re-investigation committee report (published also on the Hamamatsu City website), two cases of school bullying that my daughter was bullied by her classmates during the first year of junior high school were admitted, and there were also bullying cases in elementary school days. At times, it was recognized that there was persistent school bullying in the first year of junior high school, teachers did not correspond appropriately to school bullying problems and ignored national guidelines and tried to cover up school bullying matters.

Hamamatsu City Board of Education apologizes for hiding school bullying, 2022/08 Shizuoka Shinbun

It dates back to July 2016 that the school recorded and acknowledged two cases of bullying that my daughter had been suffered in the first year of junior high school. At the same time, Mother talked with the General Education Support Center that my daughter had been bullied in sports club activities, she was reluctant to go to school, refused attending school, and attempted suicide such as cutting wrists because suffered from bullying. Mother complained about her daughter's emotional damage caused by school bullying, but the school vice-principal said to her mother "Wrist cutting is a family problem, that never be a school one". Mother heard that the General Education Support Center would inform the school to correspond to solve school bullying problems, but the school did not respond at all even though summer vacation was over. So we had no choice but to transfer the other school but it was refused by the city board of education. In the end, she transferred to another school in the district where we run the pub from the second semester, at first, my daughter was able to go to school but she found at school those cousins who had bullied her. In October 2016, my daughter was diagnosed with PTSD accompanied by dissociative symptoms and stopped attending school.

I once gave up asking for an investigation into school bullying on my daughter, but in May 2018 (at the 3rd year of her middle school), I consulted with the General Educational Support Center again about it. In October of the same year, they finally recognized these bullying as a "serious school bullying." A report was made to the mayor in December of the same year, and the board of education began to investigate about school bullying. However, my daughter could not attend the ordinary high school due to long absence from school, and in July of her first year of correspondence high school, she tried to commit suicide by drowning.

My daughter's PTSD and dissociation symptoms due to bullying were severe, and she was often violent. I once had my face scratched by my daughter and was covered in blood. But she had no memory due to dissociation symptoms, and she looked at me and said, "What's wrong, Mom?" Sometimes she ran out onto the road in front of my house, and as our family struggled to deal with it, I was desperate and I thought many times, "Let's die together with my daughter." In the daily report of her school homeroom teacher on October 27, 2016 in the disclosed medical materials, there are descriptions of "seeing ghosts", "sexual assault in fifth grade", and "more than 10 boys", but the child psychiatrist in charge of her clearly told me that my daughter was suffered from sexual school abuses, but when he was questioned by the Board of Education, he replied, "I only said it was possible," and refused to issue a medical certificate.

静岡県浜松市の女性・アキコさん（18、仮名）が幼稚園から中学までいじめを受け、自傷行為や自殺未遂を繰り返した。不登校にもなった。主治医からは心的外傷後ストレス障害の診断を受け、今でも通院中だ。

保護者の要望で、浜松市教育委員会が、いじめ防止対策推進法における「重大事態」として調査した。しかし、保護者と調査に対する見解が合わず、市長が再調査を決めた。再調査委員会は2022年3月22日、最終報告書を公表した。継続的な嫌がらせをいじめと認定したが、証言が得られなかったとして、性的ないじめは断定しなかった。

一方、アキコさんの保護者が求めた開示資料には、小学校の教頭（当時）のアキコさんに対する印象として、「男の影?」「色っばい?」と記載されていた。小学生の教え子に対する印象として、なぜこうした不適切な文言が使われたのか、報告書での指摘はない。

アキコさんは高校中退後、高卒認定資格を取得。現在はフリーターだ。筆者の取材に対して、性的な被害を含めていじめられていたこと、自傷行為や自殺未遂を繰り返してきたことを語った。



周囲からは「いじめてもいい存在」になっていた

実は、アキコさんへのいじめは幼稚園から始まっていた。幼稚園への送迎バスに乗ろうとすると、加害者Aに「乗るなよ」などと言われたり、不快に思われるあだ名をつけられた。いじめ防止対策推進法における「いじめ」の定義では、幼稚園は含まれず、調査対象外となっている。ただ、中学までのいじめは、この頃から継続しているものだ。

「加害者Aとは近所なので、今もまだ会います。『死ね』と言われることもありました」

幼稚園教諭にそのことを言うと、「バス通園をやめてはどうか」などと、いじめを解消する対応はとられなかった。

結局、このことが後を引く。2010年、小学校に入学してからもいじめは続いた。加害者Aとは6年間、クラスは一緒にならなかったが、帰宅する方向は一緒だったし、複数の加害児童から叩かれたり、蹴られたり、石をぶつけられた。ランドセルを引っ張られ、転ばされることもあった。傘で叩かれたりもした。

小3のときは、加害者Aに加えて、加害者Bからもいじめられた。それとは別に加害者Cからもいじめに遭う。

学校は不登校・自傷行為を家庭のせいに

6月から7月にかけて、アキコさんは、スクールカウンセラーや担任らと相談をする。しかし、学校でいじめを受けていることを話すと、「家では何かあるの?」と聞かれ、その後、家のことしか聞かれなかった。

「家のことしか聞かれないので、家の手伝いで友達となかなか遊べないとか、どこの家庭でもあると思う親同士の喧嘩について話しました」

HYOGO Child Consultation Center (CCC, Chief: Toshihiko TANIGUCHI and Hiroshi KODUKI) Abducted Her Son, Locked Up Him into a Closed Ward, Dosed Psychotropic Drugs and Drove Him to Attempt Suicide

She is a Japanese mother living with his only son. She would like to report about Japanese Kids Abduction and Confinement by Governmental Child Consultation Centers. On December 14, 2021, her son was arrested under temporary protection (for research purposes) at the HYOGO Nishinomiya Orphanage (He has both parents and he has never been physically abused by both parents) Child Consultation Center (CCC) in Japan. The Child Consultation Centers' (CCC) staff (Yoshiko MORITA, Sohei SAKAGAMI) deceptively explained that her son would be able to be back home in 1-2 days, they imprisoned her son just for research purposes, but now he has been still arrested for over 9th months of prolonged temporary protection (legally at most it would be limited in 2months) by the HYOGO Nishinomiya Orphanage Children Consultation Center CCC). They, his both parents never be known where he is, how he is going and any communication with their son and parents have been completely prohibited for over these 9 months. At the end of the year 2021, the staff (Yoshiko MORITA, Sohei SAKAGAMI, Yayoi TOMOGANE and Yuki NOMURA) of the Nishinomiya Orphanage Children's Consulting Center (CCC) said that her son would be returned to home in the care of his relatives (Grand Mam and Aunt), but they had deceived his family and relatives and he never come back home again.

After the Nishinomiya Orphanage Children's Consulting Center's (CCC) prolonged temporary protection (actually that is abduction and confinement), the child's mental and physical condition deteriorated gradually, and he could not be allowed to go to junior high school, suffered from poor physical condition (Tic, Tourette, Insomnia, Nightmare), Corona Infection with high fever (2 weeks hospitalization), infant regression (emotional anxiety) , weight loss, visual acuity halved and astigmatism (medically that is "Affection Deprivation Syndrome and Child Growth disorder"). For these 9 months, he has been kept out of school, no education and no study, locked up in a closed ward, been psychotropic drugged, had no contact with friends and families, and he has to even eat meals alone. Her son has lost all of his will and energy to live up, and his academic ability is declining. Arrested in CCC facility her son is suffered from mentally illness collapse, he has had self-suicidal thoughts and attempted suicide. Her son has been missing his mother so much. Soon after a month he was kidnapped by CCC in January He said, "I want to leave the Nishinomiya Orphanage CCC facility, I want to go home as soon as possible, and I want to see my parents." His mother has been repeatedly falsely explained and fooled by the Child Consultation Centers (CCC) staff (Yoshiko MORITA, Sohei SAKAGAMI, Yayoi TOMOGANE and Yuki NOMURA) that her son consistently insisted that he would not want to go home and not to see his parents. His parents also have found many descriptions on his reports suggesting corporal punishment and abuses to their son by the Nishinomiya Orphanage Children's Consulting Center's (CCC) staff in the facility. During this time the Nishinomiya Orphanage CCC's staff has been making deceptive remarks to parents, and has never responded to his parents sincerely. The Hyogo Children's Consultation Center's (CCC) staff said that it was a complete ban on parents visitation and communication based on "the Child's Will", but it was found to be false in the Article 28 trial at Amagasaki branch of Kobe Family Court (the Nishinomiya Orphanage Children's Consulting Center deceived his mother and filed a lawsuit to fabricate the physical abuse by his mother, place her son into a mental treatment facility, he has never have a mental illness requiring hospitalization).

On June 16, 2022, a child psychiatrist (Naotoshi Kinoshita, Child Psychiatrist, Hyogo Kokoro Medical Center) issued a medical certificate (Forged Medical Note; deteriorating physical and mental condition after arrested by the Nishinomiya Orphanage Children's Consulting Center (CCC) was "due to mother's abuse"), his parents visitation and communication were completely prohibited through the issued administrative sanctions. There is no evidence of parental physical abuses, and it is a fact that the physical and mental conditions have deteriorated due to the separation from his parents, prolonged the Nishinomiya Orphanage CCC facility arrest, confinement into a closed ward, psychotropic drugged, the son has lost overall motivation to live and attempted to suicide repeatedly.

In 2017 to 2019, the child was suffered from school bullying (teacher obscenity, at school basketball club) from the 2nd to 4th grades of elementary school. His mother has asked the Nishinomiya City Board of Education to investigate about school bullying and school rape. The School, the city Board of Education and School Lawyer (Satoshi SOGA) ordered his mother to visit Nishinomiya Children's Mirai Hospital Center see a child psychiatrist (Yuka WATANABE, Ayako KOTANI). Now we have heard that in Japan there are many cases in which parental abuses and child developmental disorders are fabricated to cover School Bullying and School Rapes.

In fact, Mother and son were seeking treatment for the school bullying (teacher obscenity) PTSD, all child psychiatrists (Dr. Yuka Watanabe of Nishinomiya Children's Mirai Hospital Center, Dr. Tomomi Kameoka of the Hyogo Psychological Care Center, and Dr. Yoko Araki of Osaka Psychiatric Medical Center) excused that they could not accept any school bully including sexual abuse and refused to treat these school abuses. They said that they could treat if these school bullying would be fabricated to and replaced by family abuses and child developmental disorders.

Mom and kid were told to use a medical institution outside the Hyogo prefecture because all child psychiatrists in Hyogo could not offer the medical treatment and could not write any medical reports because of being caused by school bullying (teacher obscenity) PTSD. The Child Psychiatrists could only deal with child's developmental disorder (ASD) and parental abuses to cover school bullying. His mom has asked over 10 Children's Psychiatric Hospitals to have a medical second opinion report but all of them have been refused because they cannot write any paper that goes against governmental Hyogo Orphanage Children's Consulting Center (CCC).

Before HYOGO Nishinomiya Orphanage Children's Consulting Center's (CCC) abduction, the child was tall, healthily weighed, had good visual acuity (both eyes) , he was muscular, strong and healthy, and had a sturdy build that would never be abused by his parents. He is now 13 years old. According to the statistics of the Japanese Ministry of Health, Labor and Welfare, 98.3% of child deaths due to parental abuse are 7 years old or younger, and 98.4% of abused parents are under 45 years old. 80-90% of abusive parents are under the age of 20-30 years old. We hope the recommendations and advice of the United Nations Commission on the Human Rights of the Child so that the Japanese Government and Governmental Child Consultation Centers (CCC) can make appropriate Child-Rearing environment and decisions. We urge the United Nations to abolish Child Abuse such as abduction, confinement, and psychotropic drugged on children under the guise of welfare and family support by Japanese schools, Boards of Education, Child Consultation Centers (CCC), Family Courts, public welfare workers and divorce CCC kidnapping lawyers.

兵庫県は7日、県中央こども家庭センター（児童相談所、明石市）の一時保護所に入所している幼児ら8人が新型コロナウイルスに感染したと発表した。新規入所を停止しており、必要があれば児童養護施設などに一時保護を委託する。相談業務は別棟で行っているため継続する。

県児童課によると、入所中の幼児と児童計5人と、一時保護業務に携わる職員3人が感染。4日に幼児が発熱し、その後、入

所者や職員で症状が相次いだという。感染した幼児と児童のうち3人は容体の急変などに備えて入院している。

同センターの一時保護所には現在約30人が入所しており、濃厚接触者の部屋を分けるなどして保護を継続。面会は制限している。（土井秀人）

CONCLUSION

Despite receiving recommendations from the United Nations, Japan's Child Consulting Centers (CCC) still fail to comply with the Convention on the Rights of the Child, such as CCC have forced family long-term separation of parents and children, even if there is no parental abuse. On the surface, it appears that the situation has improved due to revisions to the law, but there is no end to illegal crimes that exploit loopholes in the law, such as unscrupulous divorce kidnapping lawyers, CCC abduction lawyers and CCC child psychiatrists who have repeatedly misdiagnosed to secure CCC budget and locked healthy children in closed wards and psychotropic drugged under off-label prescription.

With the shooting incident of former Prime Minister Abe, the extremely inappropriate political relationship with the cult religion "Family Federation for World Peace and Unification" has become clear. Tetsuya YAMAGAMI, who committed this shooting crime, is reportedly the victim of his mother's addiction to the cult religion "Family Federation for World Peace and Unification", which led to the destruction of his family. Despite the fact that there are many other cult victims all over Japan, the media has been regulated, newspapers and mass media have not reported on it, and the government has ignored and neglected the actual damage, and for many years there has been no relief. These facts that the government has inappropriate relationships with cult religion and destroyed Japanese families are slowly coming to light.

Japanese government, CCC welfare public workers and even school teachers do never comply with the Convention on the Rights of the Child. Although it is not reported in newspapers or mass media, we and our families have actually experienced in Japan. We report the facts and violations of treaties related to the human rights of children in Japan. Again we would inform you of the situation of Human Rights Violations in Japan. We would like to ask you to admonish that the Japanese government comply with the Convention on the Rights of the Child.



Tetsuya YAMAGAMI, his family was destroyed by a cult religion related to the government, shot former Prime Minister Abe to death with a self-made gun.
