Excellency,

In my capacity as Rapporteur on Follow-up on Concluding Observations of the Committee on the Elimination of Discrimination against Women (CEDAW), I have the honour to refer to the examination of the fifth periodic reports of Azerbaijan, at the Committee's sixtieth session, held in March 2015. At the end of that session, the Committee's concluding observations were transmitted to your Permanent Mission. You may recall that in paragraph 45 on follow-up on the concluding observations, the Committee requested the State party to provide, within two years, further information on the specific areas of concern identified in paragraphs 15 (a) and (b) and 23 of the concluding observations.

In September 2017, the Committee sent a reminder to the Permanent Representative, observing that the information sought by the Committee had not yet been provided. The Committee sent a second reminder in November 2017.

In the absence of a follow-up report, the Committee invited the Permanent Mission for a meeting in February 2018. During the meeting on 23 February 2018, the Deputy Permanent Representative of Azerbaijan and the Rapporteur on follow-up agreed on the submission of a summary of the State party's follow-up report within one month of the reception of this letter.

The Committee looks forward to pursuing the constructive dialogue it has started with the authorities of Azerbaijan on the implementation of the Convention. In this context, the Committee seeks to receive your response within the mutually agreed deadline, and no later than 30 April 2018.
