#### I. LIST OF NATIONAL TARGET PROGRAMS IN THE PERIOD OF 2012-2015

(Approved by Decision 2406/QD-TTg dated 18<sup>th</sup> December 2011 of the Prime Minister on the Approval of List of National Target Programs in the Period of 2012-2015)

## 1. National Target Program on Employment and Vocational Training

- a) The Sub-Projects:
  - Project 1: Renew and development of vocational training;
  - Project 2: Vocational training for rural workers;
  - Project 3: Loan for job creation from National Fund for Employment Promotion;
  - Project 4: Support for the sending of laborers to work abroad under contracts;
  - Project 5: Support for development of the labor market;
  - Project 6: Enhancement of capacity, communication, monitoring, and evaluation on the implementation of the Program.

## b) Responsible agencies for management and implementation:

Ministry of Labor - Invalid and Social Affairs shall preside over and coordinate with other relevant ministries, organizations and localities to manage and organize the operational implementation of the Program.

## 2. National Target Program on Sustainable Poverty Reduction

- a) The Sub-Projects:
  - Project 1: Support of infrastructure investment for poor districts and communes with special difficulties in coastal, coastal and island areas;
  - Project 2: Support of infrastructure investment for villages with special difficulties, border villages;
  - Project 3: Expansion of model of poverty reduction;
  - Project 4: Improvement of capacity of poverty reduction, communication, and monitoring and evaluation on the implementation of the Program.
- b) Responsible agencies for management and implementation:
  - Ministry of Labor Invalids and Social Affairs shall be responsible for overall operational management and coordination of the implementation of the whole Program; shall preside over and coordinate with relevant ministries, organizations and

- localities to manage and organize the operational implementation of Project 1, Project 3 and Project 4;
- The Committee for Ethnic Minority Affairs shall preside over and coordinate with Ministry of Agriculture and Rural Development and other relevant ministries, organizations and localities to manage and organize the operational implementation of Project 2.

## 3. National Target Program on Clean Water and Rural Environment Sanitation

- a) The sub-projects:
  - Project 1: Supply of water for rural areas, rural environment;
  - Project 2: Rural Sanitation;
  - Project 3: Enhancement of capacity, communication, monitoring and evaluation on the implementation of the Program.
- b) Responsible agencies for management and implementation:
  - Ministry of Agriculture and Rural Development shall be responsible for overall operational management and coordination of the implementation of the whole Program; shall preside over and coordinate with relevant ministries, organizations and localities to manage and organize the operational implementation of Project 1 and Project 3;
  - Ministry of Health shall preside over and coordinate with Ministry of Agriculture and Rural Development and other relevant ministries, organizations and localities to manage and organize the operational implementation of Project 2.

## 4. National Target Program on Health

- a) The sub-projects:
  - Project 1: Prevention and combat against dangerous diseases in community (leprosy, tuberculosis, malaria, dengue fever, cancer, hypertension, diabetes, protection of mental health for community and children, chronic and obstructive pulmonary disease and chronic);
  - Project 2: Expanding immunization;
  - Project 3: Reproductive health care and improvement of the infant nutrition;
  - Project 4: Cooperation between civil and military medical services;
  - Project 5: Improvement of capacity, communication, monitoring and evaluation on the implementation of the Program.
- b) Responsible agencies for management and implementation:

Ministry of Health shall preside over and coordinate with the relevant ministries, organizations and localities to manage and organize the operational implementation of the Program.

## 5. National Target Program on Population and Family Planning

a) The sub-projects:

- Project 1: Assurance of logistics and provision for family planning service;
- Project 2: Screening of deformity, disease, innate defects and controlling of unbalanced sex ratio at birth;
- Project 3: Improvement of capacity, communication, monitoring and evaluation on the implementation of the Program;
- Project on controlling the population at the sea areas, islands and coastal areas.

Ministry of Health shall preside over and coordinate with the relevant ministries, organization and localities to manage and organize the operational implementation of Program.

#### 6. National Target Program on Safety and Food hygiene

# a) The sub-projects:

- Project 1: Improvement of management capacity on food quality, hygiene and safety;
- Project 2: Educational dissemination and communication to ensure quality of hygiene and food safety;
- Project 3: Strengthening of capacity of testing systems on food quality, hygiene and safety;
- Project 4: Prevention and combat against food poisoning and diseases carried through food:
- Project 5: Assurance of food hygiene and safety in production in agriculture, forestry and fisheries;
- Project 6: Assurance of food hygiene and safety in production, sales in food industry and trade.

## b) Responsible agencies for management and implementation:

- Ministry of Health shall be responsible for overall operational management and coordination of the implementation of the whole Program; shall preside over and coordinate with relevant ministries, organizations and localities to manage and organize the implementation of Project 1, the Project 2, Project 3 and Project 4.
- Ministry of Agriculture and Rural Development shall preside over and coordinate with Ministry of Health and relevant ministries, organizations and localities to manage and organize the implementation of Project 5.
- Ministry of Industry and Trade shall preside over and coordinate with Ministry of Health and relevant ministries, organizations and localities to manage and organize the implementation of Project 6.

## 7. National Target Program on Culture

#### a) The sub-projects:

- Project 1: Prevention of degradation, enhancement of restoration and embellishment of monuments:

- Project 2: Collecting, preserving and promoting of the value of the intangible cultural heritages of the peoples of Vietnam;
- Project 3: Strengthening of investment in the construction and development of systems of cultural institutions, sports at the mountainous districts, remote areas, border areas and islands;
- Project 4: Support for development of system of entertainment establishments for children in mountainous areas, remote areas, border areas and islands;
- Project 5: Investment in the development of traditional art forms;
- Project 6: Strengthening of capacity of local officials in charge in cultural affairs, strengthening of communication, monitoring and evaluation on the implementation of the Program.

Ministry of Culture, Sport and Tourism shall preside over and coordinate with relevant ministries, organizations and localities to manage and organize the implementation of Program.

## 8. National Target Program on Education and Training

## a) The sub-projects:

- Project 1: Support for universal preschool education, literacy and anti-illiteracy, preserving the results of primary education universalization, universal secondary education universalization at the right age and support for universal primary education learn;
- Project 2: Strengthening of teaching and learning foreign languages in the national education system;
- Project 3: Support for education in mountainous areas, ethnic minority and disadvantaged areas; material facilities support for specialized schools, schools of education;
- Project 4: Improvement of the capacity for Program managers, and monitoring and evaluation on the implementation of the Program.

## b) Responsible agencies for management and implementation:

Ministry of Education and Training shall preside over and coordinate with the relevant ministries, organizations and localities to manage and implement the Program.

#### 9. National Target Program on Drug Prevention and Control

## a) The sub-projects:

- Project 1: Equipping means of drug combating and screening for the people's police force:
- Project 2: Equipping means and strengthening capacity of drug-related crimes prevention and control for the forces in charge of drug prevention and control under the Border Defense Force and Coast Guard - Ministry of Defense;

- Project 3: Strengthening of capacity for Customs forces in fighting against drug crimes;
- Project 4: Building of drug-free communes, wards and townships;
- Project 5: Improvement of the effectiveness of detoxification, post-detoxification management and research, application development, evaluation of drugs, medical methods in treatment and rehabilitation for drug addicts;
- Project 6: Strengthening of communication for prevention and combating of drug and monitoring, evaluation of the implementation of Program.

Ministry of Public Security shall preside over and coordinate with the relevant ministries, organizations and localities to manage and implement the Program.

## 10. National Target Program on Prevention and Combat of Crime

# a) The sub-projects:

- Project 1: Provision of facilities, weapons, support tools, professional equipment for the activities of the investigation police agencies at all levels;
- Project 2: Strengthening of capacity on prevention and combat of environmental crime;
- Project 3: Prevention and combat of crimes using high technology;
- Project 4: Development of a national crime information center;
- Project 5: Strengthening of vocational training capacity for prisoners in the prisons;
- Project 6: Strengthening of education, communication, monitoring and evaluation of implementation of the Program.

## b) Responsible agencies for management and implementation:

Ministry of Public Security shall preside over and coordinate with the relevant ministries, organizations and localities to manage and implement the Program.

# 11. National Target Program on Effective and Economical Use of Energy

# a) The sub-projects:

- Project 1: Strengthening of education, dissemination, mobilization and enhancement of awareness of the population community in effective and economical use of energy and environmental protection;
- Project 2: Development and popularization of high-efficiency and energy-saving equipment, step by step remove low-efficiency equipment;
- Project 3: Economical and effective use of energy in houses and buildings;
- Project 4: Impetus of energy saving in the transportation sector.

## b) Responsible agencies for management and implementation:

Ministry of Trade and Industry shall preside over and coordinate with the relevant ministries, organizations and localities to manage and implement the Program.

# 12. National Target Program on Responding to Climate Change

- a) The sub-projects:
- Project 1: Assessment of climate change and sea level rise;
- Project 2: Development and implementation of action plans to respond to climate change;
- Project 3: Improvement of capacity, communication, monitoring and evaluation of implementation of the Program.
- b) Responsible agencies for management and implementation:

Ministry of Natural Resources and Environment shall preside over and coordinate with the relevant ministries, organizations, and localities to manage and implement the Program.

#### 13. National Target Program on New Rural Development

The Program will be implemented in accordance with the Decision No. 800/QD-TTg dated June 4, 2010 of the Prime Minister approving the National Target Program on New Rural Development for the period 2010-2020. The Program emphasizes mainly in promoting the role of the population; the state will only play a role of giving guidance, issuing policies, and promulgating normative and regulatory instruments, providing support mechanism and staff training. Specific activities are discussed, decided and implemented by the rural community in a democratic manner.

# 14. National Target Program on Prevention and Control of HIV/AIDS

- a) The sub-projects:
  - Project 1: Information, education and communication for appropriate changes in behavior of prevention and control of HIV/AIDS;
  - Project 2: Monitoring the HIV/AIDS epidemic and harm reduction interventions;
  - Project 3: Supporting for HIV/AIDS treatment and prevention of HIV transmission from mother to child;
  - Project 4: Strengthening of the capacity for the HIV/AIDS prevention and control Centers.
- b) Responsible agencies for management and implementation:

Ministry of Health shall preside over and coordinate with the relevant ministries, organizations and localities to manage and implement the Program.

# 15. National Target Program on providing information to the mountainous, remote, border and islands areas

- a) The sub-projects:
  - Project 1: Strengthening the capacity of staff in charge of information and communication affairs at the mountainous, remote, border and island areas;

- Project 2: Provision of facilities for strengthening the based-line system on access to information and communication in the mountainous, remote, border areas and islands;
- Project 3: Strengthening the provision of information and communication to the mountainous, remote, border areas and islands.

Ministry of Information and Communication shall preside over and coordinate with the relevant ministries, organizations and localities to manage and implement the Program.

## 16. National Target Program on remedies for management of environmental pollution

## a) The sub-projects:

- Project 1: Remedies for pollution management and environmental improvement in the seriously polluted craft villages;
- Project 2: Environmental improvement and rehabilitation in some areas of seriously polluted caused by residues of plant protection chemical products;
- Project 3: Collecting and treat of waste water from Type-II urban areas in the three river basins of Nhue Day River, Cau River and system of Dong Nai River.

# b) Responsible agencies for management and implementation:

Ministry of Natural Resources and Environment shall preside over and coordinate with the relevant ministries, organizations and localities to manage and implement the Program.

## II. NATIONAL TARGET PROGRAMS IN THE PERIOD OF 2016-2020

(Promulgated together with the Resolution No. 100/2015 /QH13 dated 12<sup>th</sup> November 2015 of the National Assembly approving the policy on investment in national target programs in the period of 2016-2020)

## 1. National Target Program on building up new-style rural areas:

- a) Overall goals:
- Building up new-style rural areas so as to lifting the material and spiritual living standard of people;
- Development of a proper socio-economic infrastructure; achieving proper economic restructure and production modes; combining agricultural development with that of industry and services; combining rural development with that of urban areas;
- Creating a democratic, equal, stable rural society imbued with rich traditional cultural identities;
- Ecological environment is protected; security and public order are maintained.
- b) Specific objectives:
- Having at least 50% of the number of communes throughout the country meeting the criteria of a new-style rural commune and encouraging each province and centrally-managed city to have at least one district completing the criteria of a new-style rural district.
- The number of criteria completed by communes in the whole country on average must increase to 15 out of 19 and no commune should have completed less than five criteria.

# 2. National Target Program for Sustainable Poverty Reduction:

- a) Overall goals: Implementing sustainable poverty reduction and preventing poverty relapse; Contributing to the economic growth, ensuring social security benefits, improving material and spiritual living standard, and increasing income of people, especially the poor in the period of 2016-2020.
- b) Specific objectives:
- Gradually reducing the rate of poor households nationwide by 1.0% -1.5% per year on average; In particular, reducing the rate of poor districts and communes in extremely difficult situation by 4% per year according to the national poverty line during the period of 2016-2020.
