Chemical Weapons Atrocities

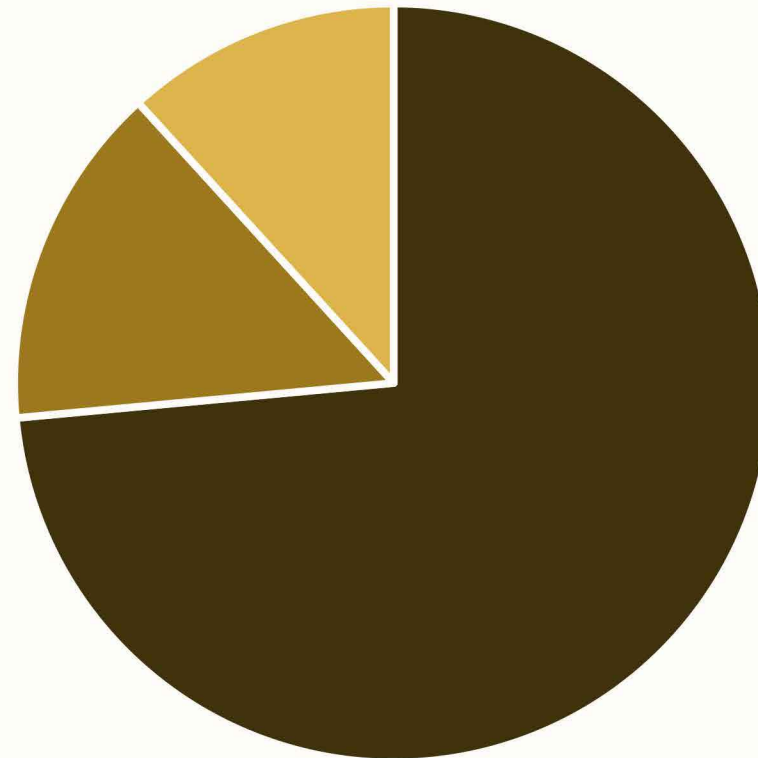
