## ***Introduction***

Sri Lanka continues to face a political and economic crisis, and a crackdown on dissidents. The Government is preparing for an extravagant celebration for Sri Lanka’s 75th year of independence on February 4, 2023, but Sri Lankan people are still struggling to afford a decent meal. Efforts to stop the March 2023 local authority elections include threats to the lives of election commissioners and claims that there is no money for the elections. Despite the continuing debt crisis in Sri Lanka, the IMF has postponed its restructuring assistance. Ongoing government repression includes the detention and torture of student leaders such as Wasantha Mudalige. Protests continue decrying government repression, price hikes and government taxation policies. In January 2023, the Supreme Court issued a verdict against the former President, but other leaders were granted immunity.

This report provides updated information as well as suggested recommendations for the Sri Lankan Government to comply with their obligations under the International Covenant on Civil and Political Rights. This document supplements the May 2022 report submitted by WAN, the Alliance for Minorities and the University of Minnesota Human Rights Clinic.

## ***Constitutional and Legal Framework; Right to an Effective Remedy (Article 2)***

Our May report detailed the extension of presidential power through the 20th Amendment over the Prime Minister, Cabinet and Parliament, as well as modified the law-making process and reduced the time a bill had to remain in the public domain before the President could table it. In late October, the 22nd Amendment passed with a two-thirds majority with the aim to “empower Parliament over the executive president and curb excessive powers of the president.”<sup>1</sup> However, the 22nd Amendment does not make “any substantive changes

to the President's powers" and is simply "cosmetic."<sup>2</sup> On the reforms to the Constitutional Council, the Bar Association of Sri Lanka cited a lack of independence that could affect the "independence and integrity of the offices and institutions to which appointments will be made."<sup>3</sup> The Centre for Policy Alternatives notes that this amendment would "set up a system of government which would not address the concerns of citizens, for a more accountable and transparent government and in the long run could further undermine democratic institutions and the citizens' faith in these institutions."<sup>4</sup>

No laws currently exist to protect children from female genital mutilation. Female Genital Mutilation (FGM) also continues to be practiced in Muslim communities. Babies as old as 40 days undergo FGM, and it is seen as a cultural ritual within the Muslim community.

Article 16 of the Constitution protects gender discriminatory personal laws including the Muslim Marriage and Divorce Act (MMDA) and other cultural practices including FGM in the name of custom. The MMDA is discussed further below.

### **Suggested Recommendations.**

- Ensure nominations to the Constitutional Council and its Independent Commissions are transparent and devoid of partisanship.
- Abolish the executive presidential system and return to a full parliamentary constitutional democracy.
- Limit the President's power to determine the number of Ministers and Ministries and the assignment of subjects and functions to such Ministries, as well as the Secretaries to the Ministries.
- Reform Article 16 of the Constitution to ensure all the laws conform with Article 12 so that everyone is treated before laws equally.
- Implement the recommendations given in the report submitted by the public representation committee on constitutional reform (in May 2015) to advance constitutional reforms that guarantee the independence of key institutions, including the judiciary and the Human Rights Commission, and advance the devolution of political authority, which is integral to reconciliation.
- Legally prohibit Female Genital Mutilation/Cutting while reforming all discriminatory laws to comply with the Article 12 of the Constitution.

### ***Non-Discrimination and Equal Rights of Men and Women (Articles 2, 3, 25 and 26)***

The July 2020 List of Issues asked the Government to report on progress on reforming discriminatory legal provisions including the Land Development Ordinance of 1935 and the Muslim Marriage and Divorce Act of 1951.<sup>5</sup> It also asked the Government to clarify and report on the status of lesbian, gay, bisexual, transgender and intersex (LGBTI) rights, including whether a prior recommendation to explicitly prohibit discrimination on the grounds of sexual orientation and gender identity in the draft Constitution was accepted, the status of amendments to Penal Code sections 365, 365A and 399, and report on discrimination against and social stigmatization of LGBTI persons, including under the Vagrants Ordinance of 1841.<sup>6</sup>

### **The Land Development Ordinance.**

We welcome the March 2022 LDO amendment to allow male and female children to inherit, and urge the State to proactively implement the LDO, including actions to address the long-term discrimination, and publicly report on its actions.

### **Constitutional deficits in Article 16 and the Muslim Marriage and Divorce Act.**

On November 8, 2022, women were once again denied from being Quazis, when the Sri Lankan Supreme Court refused petitions filed by Muslim women challenging a Gazette notification from October 7, 2022, which said that only Muslim males can be appointed as Quazis.<sup>7</sup>

Since late 2022, a senior lawyer advocating for MMDA reform has been harassed by elected representatives.<sup>8</sup> In particular, at a December 8, 2022, meeting, called by the current Justice Minister, the sole female member of the current MMDA reform committee was harassed after she explained an aspect of the Act. Muslim parliamentarians shouted at her, and the current environmental minister warned her not to express herself. She, along with the former chair of the MMDA reform committee and young women reform advocates were accused of being representatives of NGOs. This is significant because reformists are continuously attacked by conservative and radical sections of the community and in the backdrop of heightened anti Muslims rhetoric and the 2019 Easter Sunday attack, some of the women's rights activists and reformists fear for their lives.

In early December 2022, 18 male Muslim members of Parliament signed a statement demanding retention of the discriminatory Quazi system with female participation and 'conditional' polygamy.

On January 19, 2023, President Ranil Wickramasighe was the chief guest and spoke at the All Ceylon Jamiyyathul Ulama's (ACJU) 100-year celebration.<sup>9</sup> ACJU, a male only organisation, has spread false information, and vilified and intimidated the Muslim community, including Muslim politicians who support MMDA reform and has campaigned against reforms by spreading hate and misinformation. The President in his speech carefully cautioned the ACJU to be modern.

The Sri Lankan Government must reform the MMDA immediately and give the option to Muslim couples to marry under the GMRO in order to prohibit child marriage and ensure that women are equally represented and protected before the law. The proposal to address discriminatory provisions submitted by then Justice Minister Ali Sabry in July 2021 should be passed as the amendment to the MMDA as early as possible.

### **Penal Code Sections 365, 365A and 399.**

Sections 365 and 399 of the Penal Code have been used to "target individuals based on their real or perceived gender identity or expression."<sup>10</sup> In August 2022, the President amended Articles 365 and 365A to remove arbitrary arrest provisions;<sup>11</sup> however, WAN continues to advocate for the removal of these discriminatory provisions in their entirety.

### **The Vagrants Ordinance 1841.**

The Government gave no response to the Committee’s question about arrests under this Ordinance.<sup>12</sup> However, this Ordinance has been used to target sex workers; transgender persons; women in general, especially those working at night; and same-sex couples for arbitrary harassment, arrest and detention.

### **Suggested Recommendations.**

- Take affirmative measures to proactively implement the Land Development Ordinance, including actions to address the long-term discrimination, and publicly report on the progress.
- Amend the MMDA so that it is consistent with the Fundamental Rights chapter of the Constitution.
- Reform the GMRO so that two Muslims can marry under either the GMRO or a reformed MMDA.
- Repeal Penal Code Sections 365, 365A, and 399.
- Repeal the Vagrants Ordinance.

### ***Gender-based violence (Articles 2, 3, 6, 7 and 26)***

#### **Domestic violence (DV).**

Since the escalation of the political and economic crisis in May 2022, women and girls are at even greater risk of sexual and domestic violence. District officials have reported rising domestic violence rates, and victim services are facing a funding crisis, meaning that women cannot easily access resources and safehouses.<sup>13</sup>

WAN has also recorded curtailed mobility and resources for women’s groups providing victims with protection, legal-aid and other services. Particularly vulnerable were women whose partners lost their jobs. The pandemic caused increased rates of alcoholism, which contributed to rising domestic violence. In addition, court closures prevented women from accessing remedies, and many victims were thus unable to obtain orders of protection or otherwise file claims against their abusers.<sup>14</sup> The government’s budget has cut essential services such as livelihood support and safehouses.

#### **Female protestors and those who come to their aid.**

Women are also victims of increasing Government repression of unarmed students and other activists. Women are commonly physically assaulted during protests and while in police custody. Female officers who come to victims’ defense are also assaulted.

#### **Sexual bribery.**

Sexual bribery, particularly of widows or divorcees, or women seeking government help, remains a problem, in the context of so-called “national security laws” (described below). The issue also extends to women seeking any government services. The primary legal tool used to combat the issue, the Bribery Act, contains vague language, does not address actions by non-state actors, and is rarely and inconsistently enforced. In the 1998 case *Sri Lanka v. Abdul Rashak Kuthubdeen*, Sri Lanka’s High Court held that “demanding sexual favors” falls under the auspices of the Bribery Act. Nonetheless, victims of sexual bribery rarely report their experiences due to fear of shame and stigma. The Bribery Act’s failure to include the language of sexual bribery leaves a legal gap, thus failing to recognize sexual bribery as a cognizable harm, despite the 1998 *Kuthubdeen* case.

Amending the Bribery Act would allow victims to feel more confident bringing claims of sexual bribery forward. Fears of reporting sexual bribery are compounded by power imbalances between victims and perpetrators. In North and East Sri Lanka, paramilitary groups also commit sexual bribery, and women who are poor, disabled, single, or female heads of households are particularly vulnerable to being targeted.

In November 2022, the Centre for Equality and Justice published a study on the health sector and concluded that sexual bribery has severe impacts on women and LGBTQI survivors.<sup>15</sup> This study noted the particular vulnerability of sex workers.<sup>16</sup> The experiences of victim-survivors reveal that the effects of sexual bribery cause “internal stigma and stigma in the community due to the incident.”<sup>17</sup> The COVID pandemic and the recent economic crisis have worsened the impacts of sexual bribery and severely limited survivors’ access to justice.<sup>18</sup>

### **Impunity/lack of access to justice.**

Many sexual and gender-based violence (SGBV) survivors do not have the legal knowledge necessary to access available remedies. Many women remain unaware of their rights and whether or not relevant laws apply to them and their circumstances. Many women are also unaware of how to access counseling, support, and legal services.

Women also face social and cultural barriers to reporting abuse. Women fear familial destabilization, harm to their marriages, or even the prospect of losing economic resources or housing as a result of reporting crimes of gender-based violence committed against them. Social stigma, victim blaming, and women’s continued economic dependence on male perpetrators prevent victims from seeking help or accessing legal remedies. Court backlogs and lengthy judicial processes also deter women from seeking formal redress.

In 2022, the OHCHR expressed concern about the additional vulnerability of women survivors advocating for justice with security forces and authorities.<sup>19</sup> Law enforcement’s continued use of mediation to resolve domestic violence crimes during government lockdowns, for example, has put victims at risk.<sup>20</sup> Treating sexual domestic violence as a “marital conflict” that can be sorted out through cooperation from both parties trivializes the crime and can put survivors at risk of further violence and abuse.<sup>21</sup>

Accountability for public officials who have committed acts of sexual bribery is lacking. Often, officials are simply transferred to a different department as punishment for their actions. Survivors also face many barriers to accessing justice. Poor women do not always have the money to hire a lawyer, and gathering evidence can be a lengthy and cumbersome process, thus causing many women to abandon their cases. Some victims do not understand that sexual bribery is illegal, or do not know how to go about filing a complaint.

### **Suggested Recommendations.**

- Amend the Bribery Act to prohibit sexual bribery.
- Enact and enforce a zero-tolerance policy against sexual bribery.
- Increase the number of domestic and sexual violence shelters in all regions of the country.

- Ensure that victims of all genders of sexual and gender based violence have free and fair access to culturally appropriate, unbiased, effective and immediate resources to address the crimes committed against them.

### ***States of Emergency and Counter-terrorism Measures (Articles 2, 7, 9, 10 and 14, 18, 19, 23, 26)***

#### **Prevention of Terrorism Act.**

The Prevention of Terrorism Act (PTA), Sri Lanka’s most prominent anti-terrorism law, was enacted in 1979 as a “temporary” measure to curb a Sinhala youth uprising in the South. Soon it became permanent and was used to target ethnic minorities, particularly young Tamil men, in the North and East. It has long been criticized for its lack of compliance with international law and standards. Despite recent amendments, the PTA contains overly broad and loose definitions of terrorism, national security, and the nation’s sovereignty. This has facilitated the Government’s use of torture to secure confessions from detainees, arbitrary arrests, long detentions with limited access to family and counsel, and the targeting of minorities. Sri Lanka has a vibrant civil society and a low threat of terrorism, but a dangerously authoritarian and corrupt government is using the threat of terrorism to concentrate Executive power and attack critics and human rights defenders. The Government claims to be reforming the PTA and has stated that by March 2023 it wants to repeal the PTA and replace it with a new Counter Terrorism Act (CTA).

On March 22, 2022, Parliament passed a series of amendments to the PTA, but the effect has been futile. Our May 2022 report detailed the inadequacy of these amendments and their failure to bring the law into compliance with international standards. This failure was also recognized by numerous UN Special Procedures and nongovernmental organisations.<sup>22</sup>

However, there has been no transparency or any consultation whatsoever with victims and indirectly affected community members, especially members of the Tamil minority who have suffered the most under this law. (See below for a specific discussion on the impact of the PTA on minorities.) Civil society had its own broad-based consultation with many local-level activists, and a report was submitted on the CTA. However, the Government did not provide feedback nor communicate about the amendments with either these civil society organisations (CSOs) or victims they are in contact with.

In November 2022, the Government announced that it would be replacing the PTA with a new National Security Act and would be consulting a panel of “experts.”<sup>23</sup> This is highly confusing to civil society and suggests that the Government will not just repeal the PTA but bring in another repressive law. The “experts” are those that are expected to be supportive of Government proposals such as retired judges, and other former government and military officers rather than community-based human rights advocates. The motivation for legal reform is at least in part to satisfy the Government’s GSP+ application that will be reviewed by the European Union in early 2023 in order to decide whether Sri Lanka qualifies for the new GSP+ concessions; the lack of consultation with victims and civil society should also be considered in GSP+ review.<sup>24</sup>

Further, the Government is strengthening anti-terrorism measures through various bills such as the De-radicalization Bill and Rehabilitation Bureau Act which are described in our prior report and below.

Persons wrongfully detained under the PTA have no right to be compensated for the harm they suffered in detention or once they have been released.<sup>25</sup> WAN has worked with at least 3 inmates who became physically

challenged after being in detention. No government support has reached them so far, including the disability allowance, since they are still on bail and continue to be labeled as terrorists. Instead, scapegoating has led to lack of justice for victims and increased discrimination against Muslims, the political justification for continued use of anti-terrorism laws and repression. So far no evidence has been brought to prove those arbitrarily arrested and detained for over 3 years have had any connection to the Easter Sunday attack. Over 100 Muslims are still in prison.

The Sri Lankan government should immediately repeal the PTA, review whether those detained are held in compliance with international law standards and release political prisoners. WAN proposes to repeal and *not* replace it with the current CTA draft because of, first, a criminal justice system that is politicized, corrupt and that allows immunity over torture and disappearance, and second, an executive presidency that is infested with corruption, impunity, aggression against those seeking accountability (including a Commission on Victimisation that targets those seeking to hold Sri Lankan officials responsible for human rights violations).<sup>26</sup>

Existing laws such as the Penal Code, the Firearms Ordinance and Explosives Ordinance and related laws cover the same acts as do anti-terroristic laws<sup>27</sup> and while there are implementation issues for those laws as well, they do not have the degree of problems of arbitrariness, vague definitions, additional penalties, and lack of redress for misuse as do the counter-terrorism laws.

The repeal of the PTA would allow much-needed attention to the prerequisites of a criminal justice system that is not used for corrupt and discriminatory ends, including sexual bribery and to attack peaceful dissidents and minority groups. In consultation with civil society, transparent reform is needed to address ongoing human rights violations for victims of hate crimes, other crimes; and accountability for those in power who have committed human rights violations.

### **Misuse of the PTA to target minorities.**

Tamils have been targeted since the 1979 enactment of the PTA. At the end of the war and since, the PTA has been abused to detain Tamils especially under the suspicion of having been connected to the LTTE. The State collectively sent people alleged to be LTTE associates for “rehabilitation” without any court cases or legal hearing, detaining them for years. The Human Rights Watch (HRW) has documented arrests and the difficulty of getting information from the police. Arrests have been made for social media posts and lawyers themselves live in fear.<sup>28</sup>

Tamil detainees have been political prisoners held for years and without charge. Currently, of the 33 PTA Tamil prisoners, most of them have been in detention between 12 to 18 years. Many of those sent away did not return home and are now physically challenged because of war injuries or torture while in detention but they are not getting any treatment while in custody.<sup>29</sup> The Tamil community is also a continuous target and any memorial events or social media posts for those killed in Sri Lanka’s civil war or who were victims of extrajudicial killings are often handled using the PTA. In addition to those arrested, men and women who engage in memorial events of sufferings of the Tamil community are continuously called in by the Terrorism Investigation Division (TID) for investigation and accused of resurrecting terrorism in the country.

As our May 2022 reported, the PTA has also been used to disproportionately target religious minorities, including Muslims detained in Kattankudy. This August many of the Kattankudy detainees, even the ones released on bail, were put on the Government’s terrorist watch list, their bank accounts were frozen and their

passports taken away. For those who were released, harsh bail conditions continue, including restrictions on their mobility (such as travel bans and reporting to the police every 14 days). They and their family members are under heavy surveillance at home and face regular visits of intelligent officers. These officers tend to visit at night. The families report facing humiliation by officers belonging to different units showing up at their doorsteps. These officers that visit frequently ask the same questions. There is no coordination among the different units and the repeated visits harass families and cause fear among the children. These officers and units handle the victims differently and rarely identify who they are, with many coming in civilian clothes. The victims and families are saying they are in an “open prison” now. In some of the victims’ bail applications it is stated if the victim must move from one district to another, they should get prior permission from the Sri Lankan TID director. If summoned, they must report to the TID within 72 hours which hampers them securing long-term employment.

### **ICCPR Act.**

The ICCPR Act of 2007 should guarantee the right to peaceful protest. Instead, protesters, activists, and journalists face charges under the Act’s provisions that say “[n]o person shall propagate war or advocate national, racial, or religious hatred that constitutes incitement to discrimination, hostility or violence.”<sup>30</sup> The ICCPR Act also entitles alleged offenders to a right to a fair trial, but individuals are arrested with no credible evidence to substantiate charges. Just this October 2022, a peaceful protest against the Government and increasing cost of living resulted in multiple arrests and a tense standoff with the police.<sup>31</sup> Recommendations by the Special Rapporteur for freedom of association and assembly urged authorities to “create a safe and enabling environment for all to express their views.”<sup>32</sup> Often the ICCPR and PTA are used together to penalise dissent and minorities. Most recently these laws have targeted activists leading people’s protests against government repression of dissent, corruption and the escalating cost of living.

### **Rehabilitation Bureau Act.**

The Government has also introduced measures to dramatically expand the President’s powers to send inmates to “reintegration/rehabilitation centres” under the authority of the Defense Ministry. The Rehabilitation Bureau Act was passed hastily in Parliament on January 18, 2023 irrespective of the Supreme Court finding the bill unconstitutional and virtually saying that every provision violated the Fundamental Rights (FR) chapter and thus could not be passed with a simple majority. The Act was also passed using the fervor surrounding the need to control drugs in the country. However, drug dependent people already have dedicated legislation in the form of the Drug Dependent Persons (Treatment and Rehabilitation) Act, No. 54 of 2007. The Community Based Corrections Act, No. 46 of 1999 also provides for a court supervised community based correction scheme. Introducing a new act for rehabilitation instead of improving the two comprehensive acts which exist shows the intention of passing this act. In addition to drug dependent persons, this act applies to “such other persons as provided for by the law,” an unidentified, ambiguous category. Using the pretext of drug dependence or a “problematic person,” the President now has the power to send anyone for 2-year “rehabilitation” under supervision of the military without judicial and medical oversight. By passing this law, the Parliament has authorised the creation of rehabilitation centres without knowing who will be sent to them.

### **The gendered impact of the Prevention of Terrorism Act and related laws.**

The PTA and De-Radicalization Bill and Rehabilitation Bureau Act can further repress dissent. Women are themselves arbitrarily arrested under the PTA and they suffer sexual bribery and economic harm when male family members are targeted. Tamil women have been demanding demilitarization for over three decades and

these laws and the establishment of rehabilitation centres under the military further militarizes law enforcement to derail the already fragile security of these women and more generally minorities and dissent.

As detailed in our May 2022 report, the PTA is mostly used against men, but women too have been taken into custody and many have suffered sexual abuse as well. In particular, the law impacts Tamil and Muslim women acutely, especially when male breadwinners are taken in under this law and incarcerated without trial for many years - some for over a decade. Women and those assisting them are also under surveillance and harassed. Sexual exploitation through bribery is widespread. Officials at police stations, detention facilities, military camps, government offices and courts abuse their positions and demand sexual favours to grant access to services or information about detained loved ones. Victims are harassed to drop their complaints, and few cases are reported. In cases that are reported, perpetrators are reinstated after a short suspension or merely transferred to a different office.

Especially in Sri Lanka's North and East, civil society state surveillance and intimidation derail responses to victims' needs, including victims of domestic violence. Often small women's groups that are working with the families of PTA victims and promoting minority women's rights have been targeted by the state. TID and Crimes Investigation Department (CID) investigations are used to harass women's rights activists and beneficiaries working with women's rights organisations. One example is the day-to-day intimidation and state surveillance against Tamil mothers of the disappeared.

Gendered hate speech vilifies women rights and minority rights activists, and community-based organisations members on social media. Complaint mechanisms are unresponsive. In 2 cases, women who used these mechanisms have been further sexually harassed by male officers. Female public figures are particularly targeted for their stand against government repression and abuse of laws like the PTA.

### ***Accountability for serious human rights violations and the right to an effective remedy (Article 2, 6, 7, 9, 14, 16, 18, 19, 26)***

#### **Withdrawal from UN commitments.**

In October 2022, the UN Human Rights Council passed Resolution 51/1 to continue monitoring wartime violations in Sri Lanka.<sup>33</sup> The Government “categorically rejects” the resolution that was presented without the consent of Sri Lanka, calling the resolution “rambling” and a “drain on resources.”<sup>34</sup> The Council continues to recommend the Government “invite OHCHR to strengthen its country presence and provide technical assistance to authorities and civil society in Sri Lanka.”<sup>35</sup> As of January 2023, there are five UN special procedures waiting to visit Sri Lanka.<sup>36</sup>

#### **Transitional justice mechanisms remain deficient.**

The Human Rights Council has found that the Government has not “presented a credible new roadmap on transitional justice towards accountability and reconciliation.”<sup>37</sup> President Wickremesinghe noted in a speech on January 18, 2023 that he believes “now is the time for reconciliation, and coexistence.”<sup>38</sup> That said, nothing

“notable and concrete” has been done to follow up on the transitional justice mechanisms.<sup>39</sup> Only two transitional structures have been established.<sup>40</sup>

The Office of Missing Persons (OMP) has not been “able to trace a single disappeared person or clarify the fate of the disappeared in meaningful ways.”<sup>41</sup> While the official website of the OMPs notes that there is no “official confirmed figure”<sup>42</sup> of disappeared persons provided by the government, the Judicial Prison Affairs and Constitutional Reforms Minister reports there have been almost 15,000 complaints made to the OMP.<sup>43</sup> The OMP reported that as of August 2022, 1,341 “certificates of absence” were issued and no other action such as investigating mass grave sites have been made since 2018.<sup>44</sup> The October 2022 report of the UN High Commissioner for Human Rights criticized the OMP for its failure to effectively investigate the cases.<sup>45</sup>

The Office for Reparations (OR) website, meanwhile, does not contain key information, including a blank page for the “finances” tab.<sup>46</sup> Instead, the Office is now focused on setting up the Victims Fund as ordered by the Supreme Court, following a decision regarding the Easter bombings.<sup>47</sup> This will lead to longer wait times for reparations for the victims of war-related human rights violations. The compensation may come from a separate fund but the original purpose of providing compensation for war-affected communities is a vital role of the OR. Diverting attention and resources from the original purpose also removes attention from atrocities committed by the State.

### **Impunity for extrajudicial killing and excessive use of force.**

The UN Human Rights Council’s October 2022 report notes that “[i]mpunity remains a central obstacle to the rule of law, reconciliation and Sri Lanka’s sustainable peace and development, and remains the core risk factor for recurrence of further violations.”<sup>48</sup> In several instances of the emblematic human rights cases,” hearings continue to be postponed and “have lingered before the courts for over a decade.”<sup>49</sup> The Bribery Commission has begun investigations into Sri Lanka Police for using state assets to “use force during peaceful protests.”<sup>50</sup> The investigation was launched to determine if on-duty officers “had misused state assets to use force during peaceful protests” and began following a complaint filed on September 22, 2022 by the Young Lawyers and Young Journalists associations’ Committee Against Oppression.<sup>51</sup> If these issues are not addressed, victims of the human rights violations that were perpetrated during the civil war remain unlikely to see the needed accountability and the people of Sri Lanka remain vulnerable to further violations and a continued lack of accountability.

### **Impunity for enforced disappearances.**

Sri Lanka has one of the largest numbers of enforced disappearances in the world with People for Equality and Relief in Lanka (PEARL) estimating the number to be between 60,000 and 100,000 since the 1980s.<sup>52</sup>

On August 12, 2022, members of the Association of Relatives of Disappeared Persons held a peaceful protest marking the 2,000th day of their efforts to find answers.<sup>53</sup> Members are families of the forcibly disappeared who face threats, harassment, and attacks.<sup>54</sup> At least 138 relatives of the forcibly disappeared are reported to have died during their struggle to find the truth.<sup>55</sup>

During the 23rd session of the Committee on Enforced Disappearances in September 2022, the wife of journalist Prageeth Eknaligoda testified about the injustice surrounding her husband's disappearance.<sup>56</sup> Mr. Eknaligoda has been forcibly disappeared since January 24, 2010 after publishing an article criticizing former President Gotabaya Rajapaksa.<sup>57</sup> On January 25, 2010, Mrs. Eknaligoda went to the police to report Mr. Eknaligoda's disappearance but was detained for several hours at the police station.<sup>58</sup> Since his disappearance, Mrs. Eknaligoda has campaigned to have the Government take action in finding him.<sup>59</sup> Regardless, nobody has been held accountable for Mr. Eknaligoda's disappearance.<sup>60</sup> Mrs. Eknaligoda continues to face threats and defamation as she searches for the truth surrounding her husband's disappearance.<sup>61</sup> Mrs. Eknaligoda, noted on the International Day of Victims of Enforced Disappearances that President Wickremesinghe should "take this challenge and establish a credible mechanism to probe and carry out justice to the affected families of enforced disappearances."<sup>62</sup> Eknaligoda's case is just one of many enforced disappearances cases in Sri Lanka.<sup>63</sup>

### **Impunity for SGBV.**

Almost all rapes and other crimes of sexual and gender-based violence committed by soldiers during Sri Lanka's civil war have yet to be prosecuted.<sup>64</sup> Tamil women in particular have not achieved justice for the wartime crimes committed against them.<sup>65</sup> Out of the many instances of violence against Tamil women, only four cases (pertaining to the gang rape of four Tamil women and one Tamil girl) went to Court and led to the charging of perpetrators.<sup>66</sup> Even among these examples, only one of the four cases resulted in convictions and sentences.<sup>67</sup> A Jaffna high court sentenced the perpetrators to 20 years of prison and ordered them to pay one of the victims compensation.<sup>68</sup> Since the issuance of this verdict, however, the Appeal Court let the accused men go free and WAN is now fighting the case in the Supreme Court on behalf of the victim. The victim and her family have had to flee Sri Lanka due to their lives being threatened by the military perpetrators since the Appeal Court refused to prosecute them. The other three cases were transferred from Tamil regions to Sinhalese regions.<sup>69</sup> Witnesses were also severely intimidated, resulting in impunity for security forces who committed the rapes, and no justice for the victims of these sexual assaults.<sup>70</sup> These cases are illustrative of the widespread impunity

for security forces who committed acts of sexual violence against Tamil women. It also illuminates the lack of justice for these women, many of whom fear reprisal and have been discouraged from taking legal action.<sup>71</sup>

**Accountability: government officials are not being held accountable for past human rights violations and the Wickremasinghe administration has reinforced impunity.**

As discussed in our May report, former President Gotabaya Rajapaksa established the Presidential Commission of Inquiry into allegations of Political Victimization in 2020. The Commission recommended that 27 officials of the former President’s party receive monetary compensation due to being victims of this “political victimization.”<sup>72</sup> The compensation ranged from Rs. 700,000 to Rs. 25 million.<sup>73</sup> The Chairman of the Sri Lanka Freedom Party (SLFP) was quoted as saying that, “he will object and show his displeasure to the government over its moves to use legal means to provide compensation to certain persons under the guise of political victimization.”<sup>74</sup>

**Security sector officials accused of human rights violations promoted to high-ranking offices.**

The Government has “created political obstacles to accountability, actively promoted and incorporated some military officials credibly implicated in alleged war crimes into the highest levels of government.”<sup>75</sup> In fact, more than 28 serving/former military officers were appointed to government positions between 2020 and 2022 by the former President.<sup>76</sup> Unfortunately, the “current President has since continued to rely on military appointees and involve the military in law enforcement.”<sup>77</sup>

On January 10, 2023, the Canadian government issued targeted sanctions “against four Sri Lankan state officials responsible for gross and systematic violations of human rights during armed conflict in Sri Lanka, which occurred from 1983 to 2009.”<sup>78</sup> The four officials are former President Gotabaya Rajapaksa, former President Mahinda Rajapaksa, Staff Sergeant Sunil Ratnayake, and Lieutenant Commander Chandana Prasad Hettiarachchi.<sup>79</sup> The Minister of Foreign Affairs notes that these sanctions occurred due to the “limited meaningful and concrete action” the Government has taken “to uphold its human rights obligations.”<sup>80</sup>

**Suggested Recommendations.**

- Invite OHCHR to strengthen its country presence and provide technical assistance to authorities and civil society in Sri Lanka.
- Consent to the pending country visit requests from the five UN special procedures.
- End the influence of the military on civilian spheres, specifically removing military Presidential political appointees and removing the military presence from law enforcement.
- Reform the Office on Missing Persons to proactively and properly investigate the enforced disappearances.
- Cease the attacks and assaults on the families of the disappeared.
- Provide the Office of Reparations with sufficient resources to fulfill its purpose and maintain focus on post-war survivors and victims.
- Investigate and prosecute allegations of security sector officials accused of human rights violations.

## ***Internally displaced persons, refugees and asylum seekers (Articles 17, 27)***

### **Land seizures and resettlement: freedom of movement, right to privacy, and rights of minorities.**

The Internal Displacement Monitoring Centre (IDMC) reports that in Sri Lanka, there were some 12,000 internally displaced persons by conflict and violence at the end of 2021.<sup>81</sup> Many of these individuals still await their former residences to be released by the military following the civil war.

### **Deficient procedures and failure to timely release land impacts communities in the North and East.**

In its October 2022 report, the OHCHR noted that although President Wickremesinghe's August 2022 speech mentioned that there were many land issues to resolve, there continues to be military presence in areas where minority communities reside (i.e., the northern and eastern provinces).<sup>82</sup> This military presence prevents people from returning to their homes and in fact is an attempt to expand the military bases in those regions.<sup>83</sup> We urge the Government to provide detailed information about its statement that it has returned 92% of private land.

### **Suggested Recommendations.**

- Cease the military presence and expansions and return all of the remaining unreleased lands.
- Demilitarize the North immediately. This action must be a precondition to any political solution and dialogue.

## ***Nondiscrimination, Prohibition of Advocacy of National, Racial or Religious Hatred, Freedom, and Freedom of Thought, Conscience and Religion and Rights of Minorities (Articles 2, 18, 20, 26 and 27)***

### **Unequal protection for religious minorities and special status of Buddhism under the Constitution.**

As documented in our May 2022 report, the Government prioritizes Buddhism to the detriment of religious minorities through discriminatory rhetoric, policies, and laws. The Government has stated that the Constitution prohibits discrimination<sup>84</sup> and that non-discrimination is “an accepted norm.”<sup>85</sup> Despite these comments, Article 9 of the Sri Lankan Constitution continues to give Buddhism a “foremost” place in the state above other religions.<sup>86</sup> President Wickremesinghe has reaffirmed this sentiment in a speech given to Parliament in August 2022 in which he said he was “constitutionally bound to give Buddhism the foremost place and accordingly protect and foster the Buddhasasana.”<sup>87</sup>

### **Disadvantaging and delegitimizing religious organisations and places of worship.**

As documented in our May 2022 report, worship sites of religious minorities have historically been targeted with violence and subject to discriminatory policies. The Government has indicated that it is actively working to “ensure that all communities have the space to express their identity including the right to... practice their own religion...”<sup>88</sup> However, the 2008 circular requiring registration for religious sites with the Ministry of Buddha Sasana, Religious, and Cultural Affairs remains in place.<sup>89</sup> Routinely this circular has been used to the detriment of religious minorities preventing religious organisations from getting legal personality and proper permits, and resulting in the closure of religious sites and police harassment. There is also evidence of community hostility against religious minorities. The National Christian Evangelical Alliance Sri Lanka (NCEASL) has documented incidents of appropriation against Hindu temples including the removal of Hindu flags and the erection of Buddha statues at Hindu temples.<sup>90</sup> In another report, Buddhist monks and the Sri Lankan army acted against a court order by attempting to dedicate a new Buddhist shrine in Mullaitivu in June 2022.<sup>91</sup> The Task Force for Archaeological Heritage Management has also been used by the Government to discriminatorily reallocate land claimed by religious minorities. Last week three Buddhist chapter Mahanayakes called on the President to reiterate the functions of the presidential task force on archeological preservation, especially its work in the North and the East.

### **Incitement to violence by Buddhist extremists.**

Our May 2022 report expressed concern over the presidential task force in charge of implementing the “one country one law” concept due to the appointment of Galagoda Aththe Gnanasara Thero, a Buddhist extremist known for promoting anti-Muslim hate speech, as chair. In June 2022, the task force issued its final report.<sup>92</sup> The recommendations of that report have not been implemented to date. <sup>93</sup> WAN applauds the current administration’s decision to not continue with the task force initiative in light of the task force’s Buddhist extremist membership.<sup>94</sup>

### **Toleration of the targeting of minority religious assemblies.**

In its reply to the list of issues, the Government stated it applies a “zero-tolerance policy” towards acts of religious hatred or intolerance, that it strictly enforces laws against those who have committed violence against religious groups, and that investigations and legal action has been taken against alleged attacks on religious minorities.<sup>95</sup>

Despite these claims, violence against religious minorities continues without reproach. For example, NCEASL has recorded 53 instances of violence, hate speech, and other acts of persecution against Christians as of August 2022.<sup>96</sup> Our May 2022 report recorded multiple episodes of violence against religious minorities including: December 2019 attacks on Christian pastors, an August 2019 attack on a Methodist man, and November 2019

violence against Muslim voters. No updated information, including updated investigations or arrests have surfaced relating to these incidents to date.

In January 2023, the Supreme Court declared that former president Maithripala Sirisena and some of his senior officers were negligent in failing to prevent the Easter Sunday attacks. The parties were ordered to pay hundreds of thousands of dollars in compensation to the families of the victims of the Easter Sunday attacks.<sup>97</sup> However, no jail time will be served by any of the officials, a disappointment for some families of the victims.<sup>98</sup> Further, current President Wickremesinghe, was said to be immune from the court proceedings. WAN recognizes this step forward in accountability but continues to express concern regarding the State’s long history for impunity regarding religious violence and the inadequacy of remedies.

### **Segregated education based on ethno-religious identity and curriculum discrimination against Muslims.**

Our May 2022 report expressed concern over the lack of religious pluralism and evidence of discrimination in Sri Lanka’s education system. Sri Lankan schools continue to be segregated based on religion and language with 75% of schools being Buddhist schools taught in Sinhalese and 25% of schools (14% Hindu and 10.5% Muslim) being taught in Tamil.<sup>99</sup>

Additionally, discrimination against Muslims in the education system continues. The Sri Lankan Ministry of Defense has implemented a policy requiring review for all imported reading material containing Arabic script, Quranic translations, and Islamic education to protect against “terrorism.”<sup>100</sup> In 2022, the Ministry of Education recalled several Islamic textbooks after the Presidential Task Force for “One Country, One Law” raised concerns over “objectionable words” and claimed “they might contain ideas of extremist ideologies.”<sup>101</sup>

### **Official language discrimination creates disadvantages in public discourse, employment and access to services.**

In its reply to the list of issues, the Government stated it is actively working to ensure all persons’ “right to ... use, nurture and promote their own language” and made the assurance that “[a]ll communities participate fully in the life of the nation....”<sup>102</sup>

Currently, the Constitution of Sri Lanka does recognize both Tamil and Sinhala as official, national, and administration languages, a change from the historical recognition of only Sinhala.<sup>103</sup> Students are therefore able to be educated in either national language.<sup>104</sup> However, Sinhala alone is used for “the maintenance of public records and the transaction of all business by public institutions of all the provinces of Sri Lanka other than the Northern and Eastern Provinces where Tamil shall be so used.”<sup>105</sup> WAN, therefore, remains concerned that the use of Sinhala as the core administrative language for public records and business transactions, severely hinders minorities’ abilities “to participate fully in the life of the nation” contrary to the Government’s sentiments.

### **Suggested Recommendations.**

- Repeal Article 9 of the Constitution and provide equal protection of the law for all religions in line with Article 12.
- Repeal the 2008 circular on religious site registration or ensure its application does not have a discriminatory effect on religious minorities.
- Investigate recent discriminatory acts against religious sites.
- Build on the Supreme Court's recent ruling on the Easter Sunday attacks to change the State's history of impunity. Investigate and hold accountable those who have taken violent actions and acts of hatred against religious minorities. Establish a rhetoric and policy of unity and reconciliation.
- Ensure the Tamil language is effectively and adequately used in public records and business transactions to allow for greater community participation.

### ***Freedom of Expression, Assembly, and Association (Articles 19, 21, 22)***

#### **Harassment and attacks on journalists, human rights defenders, media workers.**

Excessive force has continued to be used against protestors, particularly students.<sup>106</sup> In the summer of 2022, the Government enacted a regulation banning protests around the capital in “high security zones,” requiring “written permission from the police ... to hold any public gathering.”<sup>107</sup> A day after this regulation was enacted, police arrested 84 people and “used tear gas and water cannon[s] to disperse protestors.”<sup>108</sup> These protests have not stopped. President Wickremasinghe has pledged to allow protests, but has also labeled protestors “fascists.”<sup>109</sup>

As detailed above, the main use of counter-terrorism laws is to target dissidents, rights activists or people thought to be dissidents based on their ethnicity or religion. Those who come to their defense including lawyers, journalists, and human rights advocates are also targeted. Both the current draft CTA and the deradicalization bill have sections that would pave ways to frame right activists as terrorists with simple allegations of radical thought or promoting radicalization or anti-state action. This would then allow the government to search offices or homes, freeze financial accounts, confiscate equipment and property and ultimately send those charged for rehabilitation without trial. Continuing arrests, detention and harassment of ethnic and religious minorities and dissidents have been documented by Sri Lankan and international NGOs. There are no available lists of current detainees and comprehensive information is very difficult to gather. WAN Co-Founder Shreen Saroor filed a Right of Information application with the prison authority and the request was denied (attached as Appendix I).

In August 2022, student leader Wasantha Mudalige and other student leaders were arrested under the PTA<sup>110</sup> Mudalige was continuously incarcerated, tortured and abused for his political views and protests. Other student leaders, including Sirdhamma Thero, have been released on bail but still need to appear in court.

The 17th of January, 2023, marked a dark day for the judiciary in Sri Lanka and is a chilling example of judicial intimidation. The Attorney General's Department (AGD) was scheduled to produce a report summarizing the evidence against Mudalige and Sirdhamma Thero. Instead, the AGD intimidated the Magistrate of Court 8 by

citing four affidavits from TID officials calling for an inquiry into a conflict of interest and the Magistrate then recused herself. The AGD did not follow the usual processing of submitting a complaint to the Judicial Services Commission about an alleged conflict of interest. The Deputy Solicitor General (DSG) refused to address requests for clarification and disrespected the Magistrate by reading the affidavits in open court. The AGD also submitted a "secret" progress report to the Magistrate, about which the Magistrate said there is no provision within the PTA. Mudalige is set to remain in custody until January 31, 2023. At that time, the Magistrate is scheduled to rule on the AGD's submission and whether the AGD has to grant Mudalige bail.

The Government's United Nations Act No. 45 lists organisations with allegations of terror financing and many individuals and charitable organisations placed on this list are prevented from functioning due to the freezing of their bank accounts and assets. The 2022 list is attached as Appendix II.

Many local organisations are forced to register with the National Secretariat for Non-Governmental Organisations (NNGO Secretariat) and if not their bank accounts are closely monitored. The NNGO Secretariat is currently under the control of the national security ministry and often local organisations are visited by terrorism investigation unit intelligence officers or are asked to report to the Terrorism Investigation Division Headquarters in Colombo and explain their work. There are severe intimidation and terrorism allegations used by these officers against these organisations and their volunteers. Organisations are often under surveillance, especially when an expatriate, a diplomat or a foreign delegation visits.

The Financial Crimes Investigation Division (FCID) and the central bank have given instructions to private banks not to accept any foreign funding directly to these organisations' bank accounts. Organisations are unable to receive funds even as low as 5,000 USD without being nationally registered. Three women's groups belonging to minority communities (member organisations of WAN) recently had their funds returned to their donors.

Every district secretariat office demands that organisations and individuals have to submit progress reports and have to get approval for future activities. Often community-based organisations are asked to apply for donor funding to undertake development activities rather than educational or awareness raising. Banks including private banks are instructed to advise civil society organisations to register under the NNGO Secretariat. On one occasion a private bank asked for a list of the names of beneficiaries from a WAN member to release the funds. It is extremely difficult for community-based organisations to work with the PTA victims at the community level. A WAN colleague who worked with released PTA detainees on psychosocial issues has been asked to present before the TID who tried to intimidate him with a warning against "resurrecting" the banned National Tawheeth Jamath and also told him that if he wanted to give relief items to the families of PTA detainees, he should get approval from the TID director.

Human rights advocates attending UN meetings have been followed and harassed upon their return to Sri Lanka. People who do not have a high profile are particularly vulnerable to this harassment. WAN members have been called for investigation for working with released PTA prisoners, and PTA detainee families and have been interrogated for over 8 hours and then accused of "resurrecting terror groups" and supporting terrorism. This trend has increased in the last few months particularly in the North and East. Community-based organisation staff members and volunteers have been called to report to the CID and TID. This included calls to report to the fourth floor of the TID in Colombo (which is an infamous location for torture).

### **Suggested Recommendations.**

- Allow peaceful protests; any use of law enforcement should comply with the principles of necessity and proportionality under international law.
- Comply with requests for information on who is detained under the PTA.
- Stop the practice of monitoring and interfering with civil society finances and travel abroad, including requiring organisations to register with the NNGO Secretariat and requiring banks to assist in interference with civil society work.

- Review and remove the ban on the local charities and individuals currently placed under the August 2022 “terrorist ban” list.
- Harrassment of NGOs, especially in the north and east (specifically regarding their finances and forcing them to register under the NNGO Secretariat) must cease.

### ***Participation in Public Affairs (Article 25)***

#### **Electoral rights.**

Sri Lanka ranks among the lowest internationally for the percentage of women in national legislatures despite women comprising 56% of the registered voting population and Sri Lanka having elected the first female prime minister in the world in 1960.<sup>111</sup> In the 2020 parliamentary election, approximately only 5% of Parliament members were women, 12 women out of 225 seats.<sup>112</sup> None of the women were from minority Tamil or Muslim groups.<sup>113</sup> Despite quotas in place for the local and provincial levels of government, there is little effort by political parties to enforce women’s full political participation. Moreover, there are various barriers to women’s political participation such as lack of transparency in political party frameworks and political finance regulations, discrimination in media, and violence against women.<sup>114</sup>

In August 2022, President Wickremesinghe sought to establish an all-party Government but has not yet succeeded with only minor parties having agreed to join and with civilians protesting against the all-government system. The President had aimed to gather political support in imposing the International Monetary Fund’s (IMF) austerity measures. On March 9, 2023, Sri Lanka will hold local elections, after being delayed last year due to the COVID-19 pandemic.<sup>115</sup> These will be the first elections following President Rajapaksa’s resignation.<sup>116</sup> Concerned over an electoral defeat, President Wickremesinghe has attempted to stall the elections, citing financial difficulties.<sup>117</sup> Other efforts to stop the elections include threats to the lives of election commissioners (and one commissioner has resigned).

#### **Suggested Recommendations.**

- Conduct the upcoming March local elections in a fair manner with no intrusion from the Government.
- Enforce the women’s quotas for the March 2023 elections and future elections.


