## Background:

The team of Human Is Right as been carying out monitoring, documentation and reporting of human rights violations and abuses in the South West region, by conducting field visits and critically examining social media platforms, print media, audi-visual platforms and through collaboration with other civil society organisations, state decentralised sevices, community focal persons, religious and traditional authorities in the region. This report aims depicts human rights violations documented between 2020 and 2024.

Our contributions falls in line with Articles 7 and 9 of the ICCPR addressing freedom from Torture and Liberty and Security.

		products destroyed by the same. Two workers of the Bakery were			
		arbitrarily arrested and illegally detained by the same POLICE			
		elements and were asked to pay the sum of Fifty Thousand Francs			
		50,000Frs CFA each to secure their release on bail.
