## HOW TO CONTRIBUTE/PARTICIPATE?

### Note for Civil Society actors and NHRIs

Civil Society actors (victims, NGOs, academics, etc.) and National Human Rights Institutions (NHRIs) are key partners of the Committee. This document explains how to contribute to the review of State Party reports and provides practical guidance on how to participate in the session (links to relevant documents, deadlines for submitting contributions, registration procedures, and contact details).

#### THE COMMITTEE

The Committee on Enforced Disappearances (CED) is the body of independent experts in charge of monitoring the implementation of the Convention for the Protection of all Persons against Enforced Disappearance by the States that have ratified the Convention. It consists of 10 members, nominated by States Parties and serving in their personal capacity. For details about the current membership of the Committee, please consult [this link](#).

# DIALOGUES WITH STATES PARTIES

## How to contribute?

As in all sessions, one of the main activities of the Committee consists in the review of States Parties' first reports and additional information on the measures they have taken to implement the Convention.

The outcome of this process is the adoption of Concluding Observations in which the Committee reflects positive aspects, concerns and its recommendations to the State Party.

The contributions of victims, civil society organizations, NHRIs and all other interested stakeholders are essential and welcome.

### First reports - Art. 29(1) of the Convention

#### What does this step of the procedure consist of?

Two years after having ratified the Convention, all States Parties must submit a "first report" to the Committee, to make a balance of the measures taken to prevent and eradicate enforced disappearances in compliance with the Convention, and of the challenges met.

The review of State Parties' first report takes place through a public constructive dialogue between the experts of the Committee and representatives of the national authorities that have some competence related to enforced disappearances.

In that context, victims, civil society organizations, National Human Rights Institutions and all interested stakeholders are invited to provide information and share their views on the progress made and challenges met as regards enforced disappearances and related issues.

Such contributions are essential to allow the Committee to have a complete and objective view of the situation. They must be made in writing, and can be complemented by short oral interventions in private meetings that take place before the dialogue with the State Party concerned (see below).

### Additional Information - Art. 29(3) and (4) of the Convention

#### What does this step of the procedure consist of?

Unlike other committees, the Committee on Enforced Disappearances does not have a system of periodic reports. However, the Committee has the responsibility to follow up on the implementation of its recommendations and of the Convention, as well as on the evolution of the situation related to enforced disappearances in the States Parties (article 29 (3) and (4) of the Convention).<sup>1</sup>

To do this, the Committee identifies the priority themes on which it will focus its dialogue with the State Party and the concluding observations it will adopt after a dialogue of three or six hours with the State concerned (duration determined by the Committee based on the situation under review).

<sup>1</sup> This interaction concludes once the Committee considers that the State Party has taken all possible measures to implement its recommendations, and as long as the prevailing situation in the country with regard to enforced disappearances so allows.

# DIALOGUES WITH STATES PARTIES

## WRITTEN AND ORAL CONTRIBUTIONS

---

### Issues to address in the written contributions

---

#### First reports

Contributions must relate to the situation of enforced disappearances in the country under review, from the perspective of their prevention, their eradication, and in relation to the rights of victims. The Committee recommends to address issues such as the search for disappeared persons, the investigation of disappearances, the related legislative and institutional frameworks, the registration of persons deprived of their liberty and access to related information, non-refoulement to countries where persons are at risk of enforced disappearance, disappearances in the context of migration and of trafficking in persons, the cooperation and mutual assistance between States Parties, so-called short term enforced disappearances and disappearances in the context of illegal intercountry adoptions.

#### Additional information

Contributions on additional information should focus on the list of priority themes identified by the Committee (see the link to the list of themes related to the 30<sup>th</sup> session at the end of the document). They can also bring to the attention of the Committee recent developments that should be addressed during the dialogue of the Committee with the State Party.

### Oral briefings

---

You can also contribute to the Committee's work through oral briefings related to the countries with which a constructive dialogue is scheduled.

In these briefings, victims and other civil society actors and NHRIs make a presentation of their concerns and what they consider as positive points and they provide updates related to the situation of enforced disappearances for a maximum of 5 minutes. The exact duration of the interventions will only be established once the number of speakers will be confirmed.

Country Rapporteurs and other experts of the Committee then raise questions to which participants are invited to reply.

For oral briefings, priority will be given to participants that have provided written inputs.

If you wish to take part in an oral briefing, please specify it when you submit your written i

inputs through the [CED online submission platform](#). Please provide all the required details in compliance with the instructions of the system.

#### Confidentiality

Oral briefings take place during private meetings just before the dialogue with the State Party concerned.

Different meetings are scheduled for civil society actors and NHRIs.

#### Online or in-person

Participation in oral briefings can be in person, or online. No interpretation is provided.

Priority will be given to requests for participation submitted within the deadline.

### LISTS OF ISSUES

---

#### What does this step of the procedure consist of?

Lists of issues (LOIs) are adopted by the Committee for States Parties that have submitted their first report to the Committee to identify the questions that will guide the constructive dialogue between the State Party and the Committee at one of the next sessions.

### WRITTEN CONTRIBUTIONS

---

At this stage of the procedure, contributions can only be provided in writing.

It is recommended that such inputs provide comments on the reports submitted by the States Parties on which LOIs will be adopted. They may also underline other issues related to the Committee's mandate that are not referred to in the State Party's report.

Upon adoption, the lists of issues are made public and are transmitted to the State Party concerned, that must reply in writing within a deadline determined by the Committee.

### LISTS OF PRIORITY THEMES

---

#### What does this step of the procedure consist of?

On the basis of the additional information submitted by a State Party, the Committee may decide to identify up to four themes that it considers as priorities to be addressed by the national authorities. These lists of themes (LOTs) will guide the constructive dialogue that will take place at one of the future sessions of the Committee.

### WRITTEN CONTRIBUTIONS

---

At this stage of the procedure, contributions can only be provided in writing.

They shall highlight what their authors consider as priority themes that the Committee should take into account in the forthcoming constructive dialogue, explaining the reasons of their relevance.

Such themes shall in the first place refer to the additional information of the State Party, and previous concluding observations of the Committee. They may also raise new issues related to the current situation of disappearances in the State Party concerned.

The Lists of themes adopted by the Committee will be transmitted to the State Party, that will have to address all the issues raised during its dialogue with the Committee at one of its future sessions, for 3 or 6 hours (duration determined by the Committee).

# WRITTEN CONTRIBUTIONS

## How to submit?

---

### Submission platform

All submissions should be transmitted through the [CED online submission platform](#). If you do not have an account on this platform, you will have to create one.

### Confidentiality

When submitting your contribution, please specify whether you wish it to be public or confidential. Confidential contributions are only shared with Committee members and secretariat.

### No anonymity

The Committee needs to know the authors of submissions to have the possibility to contact them. Anonymous submissions are therefore not accepted, and all contributions must specify the name of the submitting person, organization, or institution.

### Format and word limit

Contributions must be submitted in Word format and shall not exceed 10,700 words, plus annexes.

### PLEASE NOTE

*All contributions must be specific, reliable and objective. They must be drafted in a non-abusive language.*



### Names of victims in the contributions

The information should not contain names of victims, except if related to cases of large public knowledge, or if you can demonstrate that you count with the consent of the victim(s) (individuals who were disappeared and then located, or relatives, or representatives of a disappeared person).

### Languages

All contributions must be submitted in English, French or Spanish. As most members of the Committee use English as their working language, it is highly recommended to translate to English all documents submitted in French and Spanish. An unofficial translation is sufficient. In such case, please provide all available language versions of the document. Please note that the UN Secretariat does not translate contributions submitted by civil society and NHRIs.

## PHOTOS AND VIDEOS

---

**Unauthorized filming, photographing, recording and dissemination of audio-visual materials during the session are prohibited.**

Only accredited media representatives have the right to film and take pictures at the beginning and the end of public meetings of the Committee. They are required to wear their press badge issued by UNOG at all times when inside UN premises. Their accreditation can be withdrawn in case of misuse.

Accredited media representatives as well as photographers or camera teams hired by State Party delegations can film the introductory and closing remarks of the Head of delegation.

Cases of misuse should be brought to the attention of the UNOG Security and Safety Service and/or the UN Information Service, which can follow-up on written complaints only.

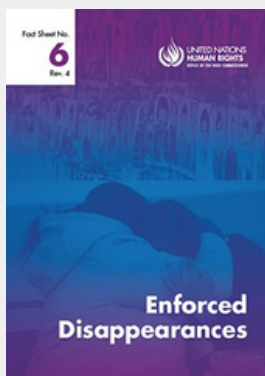

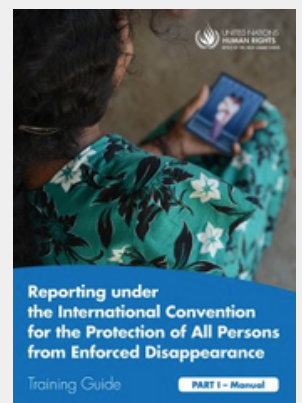
