CORRIGENDUM

The Secretariat of the United Nations (Office of the High Commissioner for Human Rights) presents its compliments to the Permanent Mission of the State of Palestine to the United Nations Office at Geneva, and has the honour to refer to its Note verbale dated 2 April 2019, related to inter-state communication ICERD-ISC-2018/3, submitted by the State party under article 11 of the Convention on the Elimination of All Forms of Racial Discrimination concerning the State of Israel.

The Secretariat has the honour to inform the Permanent Mission that the hearing scheduled on Thursday 2 May 2019, from 3pm to 6pm, will take place in Palais des Nations, **Building A, Room no. XVI** in Geneva.

If the State party wishes other experts to be present for possible consultations with the designated representative of the State party, they will have to remain in a separate room in Palais des Nations, behind Room no. XVI, to which they will be taken by the Secretariat upon their arrival.

The Committee requests each of the States parties involved to communicate the list of experts who will be present on the day of the hearing by Friday, 19 April 2019, CoB.

The Secretariat has also the honour to inform that all experts who are not accredited (those who do not have a badge from the Permanent Mission) have the obligation to register to be authorized to enter the premises of Palais des Nations. Registration must be done by each of the experts. Each expert is encouraged to have a personal account (unique email account and password) and log in to the **Registration Page** (see link in the email) using Google Chrome, Mozilla, Firefox, Safari, Edge or Opera. After registration, the experts will receive a bar code and email confirmation of the registration and need to collect their badges at the Palais des Nations, Pregny Gate.

Registration can already be done, and must in any events be finalized before the day of the hearing. A representative from the Permanent Mission can collect the badges of the representatives of the State party, and of all the experts who will be present at the Pregny Gate ahead of the meeting.
