# INTERSESSIONAL ACTIVITIES REPORT JUNE 2021 - SEPTEMBER 2021

This report covers the period from the end of the 87<sup>th</sup> Session to the end of the 88<sup>th</sup> Session. The 88<sup>th</sup> Session was conducted in-person and the CRC was the first of the Treaty Bodies to meet in this manner but with special restrictions as a result of the Covid 19 Pandemic, which still remains a factor in proceedings, affecting the ability of some States to travel to Geneva, Switzerland for in-person review.

## I. Activities of the Working Groups of the Committee.

## **Working Group on Working Methods**

### **Coordinator Luis Pedernera reports:**

The Working Group agreed to propose amendments to the reporting guidelines. The draft amendments will be prepared by the next session.

It was also agreed to consider the introduction of procedures for follow-up to the Concluding Observations and a comparative study of the practices of some other Treaty Bodies was prepared for the discussion. We also discussed how to address the backlog of reviews of State Parties reports and proposals were made to the Bureau.

# Working Group on the Rights of the Child in relation to the Digital Environment

## **Coordinator Philip Jaffe reports:**

Following consultation with its members, the decision was taken at the start of the current session to officially dissolve this Working Group. Its purpose was primarily to produce General Comment 25 and to effect its launch. During themost recent intersession and the current in person session, the following requests for participation in events related to GC 25 were honoured:

- June 29. UNCRC General Comment 25: Children's rights and the digital environment: impact assessment and corporate responsibility, *Social Media and Children's Rights*, Digital Law Center and CIDE, Université de Genève.
- August 18. *General comment 25: salient features*. Regional launch Child Rights Coalition Asia (online).
- September 1. The digital rights of children. Main takeaways from the General Comment 25 of the UN Committee on the Rights of the Child. Iranian Association for UN Studies (online).
- September 22. *Digital Citizens: Progressing children's right to be heard through social and digital media*. Ombudsman for Children and University of Dublin, Ireland.

# **Working Group on Children's Rights and the Environment**

## **Co-coordinators Philip Jaffe' and Velina Todorova report:**

This new Working Group was formed primarily to focus on the development of General Comment 26 on Children's Rights and the Environment, with special focus on Climate Change.

The group held several meetings online and in person to finalize the Concept Note, select and meet with the external partner Terre des hommes, Germany whose expertise will guide the Committee to completion of the General Comment and to agree on a work plan that will lead to a projected adoption and launch by February 2023.

# **Working Group on the DGD on Alternative Care**

## **Co-coordinators Ann Skelton and Bragi Gudbrandsson report:**

The Committee's first online Day of General Discussion on Children's Rights in Alternative Care was held on 16 and 17 September.

There was substantial inter-sessional work carried out by the Working Group, together with the OHCHR, the CSO task force, and the Children and YoungPeoples Advisory Teams in order to plan for the DGD. Over 200 submissions were received and these were compiled into a background document. Logistical arrangements were also provided in partnership with the CSO Task Force and with the support of UNICEF.

The event was hybrid in nature with Committee members participating at Palais des Nations, while attendees participated or watched on line from all parts of the Globe. Children and young people with care experience were central participants as they were key speakers in every session. Twenty five children and young people

participated in the Advisory Team and fifteen of them were speakers or participants in sessions of the DGD.

The plenary sessions featured expert inputs from UNICEF and the Special Representative of the Secretary General on Violence Against Children, as well as speakers from different regions regarding preparatory work that had been done to collect information for the DGD. Parallel working groups permitted participants to explore a range of thematic issues. The Committee expresses its appreciation to everyone who participated and all those who worked behind the scenes to make the DGD a success.

The Committee, in consultation with partners, will now embark on the next phase of this work: to complete an outcomes document and final report.

# Working Group on the Optional Protocol on a Communications Procedure (OPIC)

## **Co-coordinator Ann Skelton reports:**

The Working Group on the Communications Procedure (OPIC) held its first presessional meeting in Geneva on 1<sup>st</sup> and 2<sup>nd</sup> September to work on individual communications. The Committee has finalised eight individual communication decisions during the current session.

In addition, the Committee adopted an amendment to Rule 19 of the Rules of Procedure, approved new Guidelines on Oral Hearings and took decisions regarding the Report on Follow Up to previous decisions.

### **Sub group on Inquiries**

## Co-coordinators Hynd Ayoubi Idrissi and José Rodriguez Reyes Report:

A separate sub-group on Inquiries was developed, and held three meetings to date to review working methods and inquiry decisions.

A draft is being finalized for further discussion in the main OPIC Working Group before transmission to plenary.

# Working Group on the Draft Statement on the Rights of Children with Disabilities

## **Coordinator Velina Todorova reports:**

The Working Group met on 30 July to discuss and propose changes to the two paragraphs-14 and 23 on Violence and Justice respectively, as modified by CRPD. The agreed version was sent to CRPD, who provided their reply on 6 September. Following the DGD, this Group is presently discussing the last paragraphs on Family and Alternative Care.

#### Focal Point--Media /Twitter

## Co-coordinators Philip Jaffe' and Benoit Van Keirsbilck report:

The Committee's twitter account, @UNChildRights1, continues to gather followers which now stand at 1049. The activity revolves around signalling important UNCRC news, informing followers of participation of CRC members in various official events, and retweeting significant human rights news from within the UN system (OHCHR, Treaty Bodies, etc.). There is a growing push from external entities to promote their own news by mentioning the Committee's twitter handle.

# Focal Point of the Committee and the Office of the Special Representative of the Secretary General on Violence against Children in Armed Conflict:

## **Coordinator Hynd Ayoubi Idrissi reports:**

The joint statement between CRC / CEDAW on the rights of children born of rape during armed conflict and their mothers was adopted on 7 September by the CRC. The Office of the SRSG proposed the publication of this statement for October 2021 and will organize a side event on the occasion, in the context of the WPS week, which will also promote the collaboration between Treaty Bodies and the SRSG's Office as a Security Council mechanism.

## **Inter Parliamentary Union Focal Point**

### **Sophie Kiladze reports:**

There was elaboration of potential IPU/CRC cooperation as approved by the Secretary General of (IPU).

This was discussed by the CRC Plenary and there was a Bureau decision to invite IPU members for detailed discussion of concrete steps of cooperation during the January 2022 Session.

### **Focal point for Latin America and the Caribbean**

### José Rodríguez Reyes reports:

The members of the region held a meeting with the Movimiento Mundial por la Infancia Capitulo Latinoamericana y Caribe (MMILAC), which brings together children's organizations and intergovernmental agencies in the region.

We have agreed to maintain a permanent dialogue and work on a road map to facilitate implementation and collaboration with the agenda of our Committee.

## **Focal Point for Europe**

## Bragi Gudbrandsson and Benoit Van Keirsbilck report:

They contacted the main actors in the field of Children's Rights in both the European Union and the Council of Europe and had a first online meeting with them.

They met with the Coordinator of the Children's Rights Unit of the Council of Europe (Regina Jensdottir); the Children Rights Coordinator in the European Commission (Valeria Setti), and with the Children's Rights Coordinator of the Fundamental Rights Agency of the EU and her colleagues (Marta Tarragona Fenosa, AstridPodsiadlowski and Monica Gutierrez).

These persons already meet on a regular basis for coordination and updates of the main developments in their respective institutions. They welcomed having regular exchanges with the CRC Committee in order to support its work and promote its standards since CRC is the baseline of their work and they often make use of the CRC and other main children's rights standards.

They are interested in knowing more about the developments occurring in other regions and are willing to share their experience with them, hoping that these exchanges become a mutual source of inspiration.

We identified some areas of possible collaboration in the dissemination of the work of the Committee; support in the follow up of the COBs; development of child friendly material and promotion of OPIC, both strategically and as a part of the issue of the access to justice.

It was decided we would meet twice a year and regularly exchange information relevant to our work.

## **II. Participation of Members**

Several members participated in the University of Geneva's Summer School, "Children's Rights at the Heart of Human Rights", a first edition in partnership with the University of the West Indies, St. Augustine, Trinidad and Tobago. Members' involvement was substantive for example teaching activities as well as informal participation group discussions on the inner workings of the Committee on the Rights of the Child.
